EQUITY SUMMARY

This week saw 1,427,257 shares traded on the First Tier Market, a decrease of 36.29 per cent on last week's total of 2,240,227 shares crossing the floor. The value of the shares traded was down 28.64 per cent to \$14,525,617.96 from the previous week's value of \$20,354,263.10. NCB Financial Group Limited (NCBFG) was the volume leader this week with 26.30 per cent of the market activity or 375,408 shares traded, followed by The West Indian Tobacco Company Limited (WCO) with 15.73 per cent of the market activity or 224,554 shares traded. In third place was Massy Holdings Limited (MASSY) with 14.95 per cent or 213,375 shares traded. These shares accounted for 56.99 per cent of the shares traded this week.

The Indices ended the week in negative territory. The Composite Index decreased by 1.56 per cent or 18.43 points to close at 1,166.47. The All Trinidad and Tobago Index ended at 1,762.72, down by 1.15 per cent or 20.53 points. The Cross Listed Index slid by 2.98 per cent or 2.27 points to close at 73.95. The Small and Medium Enterprise



Index ended at 77.71 unchanged from the previous week. This week there were 7 shares advancing and 13 shares declining, while 1 share were at their 52-week high and 2 shares were at their 52-week low.

The major advance this week was LJ Williams "B" Limited (LJWB) up 14.71 per cent or \$0.25 to close at \$1.95. In second place was Ansa McAL Limited (AMCL) with an increase of 3.62 per cent or \$1.99 to close at \$57.00, Trinidad Cement Limited (TCL) followed with an increase of 1.96 per cent or \$0.05 to close at \$2.60.

Prestige Holdings Limited (PHL) was the major decline this week down 12.55 per cent or \$1.63 to close at \$11.36, Angostura Holdings Limited (AHL) followed with a decrease of 11.61 per cent or \$2.64 to close at \$20.10. In third place was WCO down 10.22 per cent or \$1.14 to close at \$10.01.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 1,125 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$25,628.75. CALYP's unit price closed at \$22.81 up 0.26 per cent or \$0.06 from last week.

On the Small and Medium Enterprise Market, no Endeavour Holdings Limited (EHL) and CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$14.75 and CINE1 closed at \$6.45 both unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


