### Local Market Summary

Trading Volumes picked up considerably this week as 3,423,023 shares changed ownership compared to last week's volume of 690,850 shares. However, it should be noted that the total volume was mainly driven by a large trade of 2,159,925 PLIPDECO shares on the second day of trading. The total value of shares traded was \$25,692,254.60 compared to \$6,417,238.98 last week.

For the first time since the week ended July 14, 2006, the Composite Index ended the week in positive territory, moving up 0.06 per cent to 869.2748. However, the All T&T Index continued on its downward trend, falling 0.73 per cent to 1,082.5699. The advance to decline ratio stood at 7 to 8.

As mentioned above, PLIPDECO was the volume leader this week, commanding a significant 65.18 per cent of the market with a total volume of 2,231,101 shares traded. Sagicor Financial Corporation (SFC) was next in line with a total volume traded of 221,137 shares or 6.46 per cent of the market. While Angostura Holdings Limited (AHL) followed with 215,028 shares traded or 6.28 per cent of the total volume changing ownership.

Capital & Credit Merchant Bank (CCMB) was the major advance this week, moving up 8 cents or 7.69 per cent on last week's close to end this week at \$1.12. The second major advance for the week was National Commercial Bank Jamaica (NCBJ), which went up 11 cents or 6.67 per cent to \$1.76. In Jamaica these shares ended the week at JMD10.75 and JMD18.44, respectively. Following as the third major advance was National Flour Mills (NFM), which rose 6 cents or 3.77 per cent to \$1.65.

The largest decline of the week belonged to PLIPDECO (PLD), which fell 75 cents or 14.29 per cent to \$4.50. Prestige Holdings Limited (PHL) was the second largest decline for the week, falling 50 cents or 9.09 per cent to \$5.00. National Enterprise Limited followed as the third major decline, dropping 40 cents or 5.06 per cent to \$7.50.

### Jamaica Stock Exchange (JSE)

In Jamaica, trading volumes were down this week, as 9,096,541 shares changed ownership compared to last week's total of 20,696,882. The total value of shares traded was JMD81,256,707 compared to the previous week's value of JMD127,436,945.71.

All three indices ended in positive territory. The Market Index was up 0.52 per cent to 86,642.27, the Select rose 0.81 per cent to 2,358.92 while the All Jamaican Composite climbed 0.71 per cent to 87,275.66.

Jamaica Broilers (JBG) was the volume leader this week with 2,682,651 shares (29.49%) changing ownership followed by Cable and Wireless Jamaica (CWJA) with 1,276,508 shares (14.03%) and Jamaica Money Market Brokers (JMMB) with 780,620 shares (8.58%).

Overall market activity resulted in 16 shares advancing and 13 shares declining. Jamaica Producers Group Limited (JP) was the major advance for the week, moving up 13.28 per cent to JMD43.00. While Mayberry Investments Limited (MIL) was the major decline, dropping 9.72 per cent to JMD2.60.
