Local Market Summary

Volumes traded this week were up on last week's volume by an outstanding 83.18 per cent with a total of 4,151,031 shares crossing the floor compared to 2,266,118 shares traded in the previous week. The value of shares traded amounted to \$94,105,496.78, up 11.18 per cent on the previous week's value of \$84,641,943.22.

This week saw all three Indices end in negative territory with the Composite Index down 13.5504 points or 1.55 per cent to close at 858.4529, the All T&T Index declined 12.7356 points or 1.08 per cent to 1,168.7372 and the Cross Listed Index dropped 1.7241 points or 2.48 per cent to 67.7565. The advance to decline ratio was 0 to 7.

Sagicor Financial Corporation (SFC) was the volume leader this week with 2,043,453 shares traded or 49.23 per cent of the total volume traded. Neal & Massy Holdings Limited (NML) was next in line with 713,244 shares crossing the floor or 17.18 per cent of all trades. National Commercial Bank Jamaica Limited (NCBJ) was the third volume leader with 458,094 shares changing hands or 11.04 per cent of the market.

Leading the declines this week was SFC, down \$1.50 or 12.00 per cent to close at \$11.00. NCBJ was next, dropping 10 cents or 9.09 per cent to close at \$1.00. In Jamaica, this share ended the week at JMD13.40. The third major decline was National Flour Mills Limited (NFM) down 5 cents or 6.67 per cent to close at \$0.70.

Jamaica Market Summary

In Jamaica, all Indices trended downwards. The Market Index declined 4,206.35 points or 5.09 per cent to close at 82,657.89; the Select Index fell 182.05 points or 9.15 per cent to close at 1,989.70 while the All Jamaican Composite dropped 5,959.65 points or 8.02 per cent to end the week at 74,301.74. Advances were significantly outnumbered by declines by a ratio of 8 to 26. Trading activity resulted in 11,064,098 shares crossing the floor valued at over JMD85,524,761.33 with Jamaica Broilers Limited (JBG) being the volume leader commanding 21.01 per cent of the market with 2,324,762 shares traded.
