## EQUITY SUMMARY

#### Trinidad and Tobago

Volumes traded on the First Tier Market this week were down on last week's volume by 74.75 per cent with a total of 1,610,888 shares changing hands compared to 6,378,753 shares traded in the previous week. The value of shares traded was \$6,590,126.60, down a considerable 87.15 per cent when compared to last week's value of \$51,301,779.46. The significant decline in the volume of value of shares traded is mainly attributable to the fact that Angostura Holdings Limited (AHL) saw 5,796,128 shares traded last week valued at \$49,267,333.00. The volume leader this week was National Flour Mills Limited (NFM) with 733,830 shares traded or 45.55 per cent of all trades.

With regards to Indices movement, both the Composite and the Cross Listed Indices registered declines this week while the All Trinidad and Tobago Index closed higher. The Composite Index lost 6.33 points or 0.65 per cent to 970.91, the All Trinidad and Tobago Index gained 5.25 points or 0.38 per cent to 1,402.67 and the Cross Listed Index slipped 2.01 points or 2.89 per cent to 67.49.

Advances outnumbered declines by a ratio of 14 to 8. The major advance was Jamaica Money Market Brokers Limited (JMMB) which rose 30.00 per cent or \$0.15 to end the week at \$0.65. The major decline was Barbados Shipping & Trading Company Limited (BST) which fell 8.74 per cent or \$2.44 to \$25.49.

There was no activity on the Second Tier Market this week. On the Mutual Fund Market, 2,500 shares of Praetorian Property Mutual Fund (PPMF) shares traded with no change in price.



#### Jamaica

In Jamaica all three major Indices closed the week in the red for the second week in a row. The JSE Market Index dropped 1,017.81 points or 1.10 per cent to 92,725.76, the JSE Select Index fell 32.82 points or 1.19 per cent to 2,752.52 and the JSE All Jamaican Composite declined 1,583.41 points or 1.62 per cent to 97,776.04. Market activity resulted in 38,729,957 shares traded valued at over J\$811,838,700.67. The volume leader this week was GraceKennedy Limited (GKC) with 30.37 per cent of the market or 11,761,597 shares.
