Second Tier Market

The Second Tier Market was inactive this week.

Mutual Fund Market

This week saw 896 shares of Savinvest India Asia Fund (SIAF) change hands. SIAF ended the week at \$75.00 up \$2.00 or 2.74 per cent on last week's close of \$73.00. There were no other trades or changes in price on this market.

Local Market Summary

This week's trading activity ended with 3,425,211 shares changing ownership, up a considerable 74.11 per cent on last week's volume of 1,967,307 shares traded. The value of shares traded stood at \$31,265,650.10, up 11.45 per cent on the previous week's value of \$28,052,602.28.

Bearish conditions returned to the market after a threeweek bull run as both Indices trended downwards. The Composite Index fell 2.4647 points or 0.26 per cent to end the week at 945.8760 while the All T&T Index dropped to 1,181.1870, down 1.35 per cent or 16.2125 points. Advances were outnumbered by declines by a ratio of 5 to 12.

National Flour Mills Limited (NFM) took the title of volume leader this week commanding 36.31 per cent of the market with 1,243,567 shares traded. FirstCaribbean International Bank (FCIB) followed with 1,162,991 shares changing hands or 33.95 per cent of all trades. Jamaica Money Market Brokers Limited (JMMB) was next with 309,364 crossing the floor or 9.03 per cent of the total volume traded.

The major advance for the week was National Enterprises Limited (NEL), up 43 cents or 6.90 per cent to close at \$6.66. Incidentally, the second and third volume leaders were also the second and third major advances this week. FCIB advanced 41 cents or 3.70 per cent to \$11.50 while JMMB rose 1 cent or 1.14 per cent to end the week at \$0.89.

Declines were led by Guardian Holdings Limited (GHL), which fell \$3.50 or 12.97 per cent to close at \$23.49. Next was NFM, down 9 cents or 11.69 per cent to end at \$0.68. The third major decline was Trinidad Cement Limited (TCL) which closed at \$7.26, down 34 cents or 4.47 per cent.

Jamaica Stock Exchange (JSE)

Similar to the local market, the Jamaica Market saw all three Indices ending in negative territory. The Market index declined 1,659.33 points or 1.71 per cent to 96,849.28; the Select Index fell 29.20 points or 1.15 per cent to 2,532.24 and the All Jamaican Composite dropped 1,472.54 points or 1.58 per cent to close the week at 92,950.88. Advances were significantly outnumbered by declines by a ratio of 9 to 19.

Market Activity resulted in 27,988,453 shares crossing the floor valued at over JMD414,929,478.32 with Cable & Wireless Jamaica Limited (CWJA) being the volume leader, commanding 41.84 per cent of the market with 11,710,832 shares traded. The major advance of the week was National Commercial Bank (Jamaica) Limited (NCBJ), which rose 5.12 per cent or JMD1.10 to

JMD22.60. FirstCaribbean International Bank Jamaica Limited (FCIBJ) was the major decline, down 23.30 per cent or JMD9.11 to JMD29.99.
