EQUITY SUMMARY

Trinidad and Tobago

The activity on the First Tier Market increased by 8.19 per cent this week with a total of 1,345,221 shares crossing the floor compared to 1,243,386 shares in the prior week. The value of shares traded grew by 6.59 per cent to \$24,221,020.64 from the previous week's value of \$22,724,596.62. JMMB Group Limited (JMMBGL) was the volume leader capturing 40.39 per cent of the market with 543,381 shares traded, followed by Ansa McAl Limited (AMCL) with 15.02 per cent or 202,028 shares. In third place was Trinidad and Tobago NGL Limited (NGL) with 14.96 per cent of market activity or 201,220 shares.

All three Indices ended the week in positive territory. The Composite Index, up by 0.52 per cent or 6.68 points to close at 1,282.26 and the All Trinidad and Tobago Index increased by 0.50 per cent or 8.65 points to end at 1,750.94, due to price surges of Guardian Holdings Limited (GHL) and NGL. The Cross Listed Index closed at 109.67, a growth of 0.59 per cent or 0.64 points this was attributed to the price increase of NCB Financial Group

Limited (NCBFG) and Grace Kennedy Limited (GKC) shares. This week there were 9 stocks advancing and 4 stocks declining, while 5 stocks are at their 52 week high and 7 stocks at their 52 week low.

GHL was the major advance, up 5.16 per cent or \$0.81 to close the week at \$16.51, followed by NGL with an increase of 4.17 per cent or \$1.00 to end at \$25.00, which is its 52 week high. In third place National Flour Mills Limited (NFM) up 2.78 per cent or \$0.05 to close at \$1.85.

LJ Williams Limited 'B' (LJWB) was the major decline, down 10.26 per cent or \$0.08 to end at \$0.70. In second place was JMMBGL with a 5.05 per cent loss or \$0.11 to end at \$2.07, Republic Financial Holdings Limited (RFHL) followed down 0.19 per cent or \$0.19 to close at \$101.50.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 10,729 CLICO Investment Fund (CIF) units traded with a value of \$225,233.00. CIF's unit price, up 0.53 per cent or \$0.11 to close at \$20.99. On the USD Mutual Fund Market, 500 Bourse Brazil Latin Fund (BBLF) units traded with a value of US\$4,050.00 BBLF's price rose by 0.25 per cent or \$0.02 to end at \$8.10
