EQUITY SUMMARY

Trinidad and Tobago

This week there were 626,563 shares traded on the First Tier Market, a decline of 48.06 per cent on last week's volume of 1,206,261 shares. The value of shares traded fell 47.27 per cent from \$7,989,229.17 in the prior week to \$4,212,610.02 this week. The volume leader, for the fifth consecutive week, was JMMB Group Limited (JMMBGL) capturing 46.26 per cent of the total volume traded this week with 289,863 shares.

All three Indices continued on an upward trend from last week. The Composite Index added 0.40 per cent or 4.75 points to end at 1,178.00, the All Trinidad and Tobago Index climbed 0.17 per cent or 2.98 points to 1,807.57 and the Cross Listed Index increased 1.23 per cent or 0.89 points to close at 73.22. Overall there were 9 stocks advancing and 9 stocks declining. JMMBGL was the major advance, rising 5.88 per cent or \$0.05 to



close the week at \$0.90 and the major decline was Trinidad Cement Limited (TCL), down 14.18 per cent or \$0.56 to \$3.39

There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 118,975 CLICO Investment Fund (CIF) units traded with a value of \$2,689,478.50. CIF's price rose 0.04 per cent or \$0.01 to close at \$22.61. Additionally, 492 Calypso Macro Index Fund (CALYP) units traded with a value of \$10,809.24. CALYP's price fell 0.09 per cent or \$0.02 to close at \$21.97. Also, 4,000 Praetorian Property Mutual Fund (PPMF) units crossed the floor with a value of \$10,800.00. PPMF's price rose 1.89 per cent or \$0.05 to close at \$2.70.
