EQUITY SUMMARY

Trinidad and Tobago

This week saw a total of 756,636 shares traded on the First Tier Market, a 3.13 per cent increase on last week's volume of 733,654 shares. The value of shares traded was up 20.75 per cent from \$9,888,412.18 in the prior week to \$11,939,974.95 this week. Guardian Holdings Limited (GHL) was the volume leader capturing 35.13 per cent of all trades this week with 265,792 shares traded.

The Indices ended the week mixed. The Composite Index rose 0.18 per cent or 2.21 points to end at 1,211.74, the All Trinidad and Tobago Index declined marginally by 0.01 per cent or 0.14 points to close at 1,834.09 and the Cross Listed Index increased 0.81 per cent or 0.63 points to close the week at 78.80. The advance to decline



ratio ended the week 9 to 6. The major advance was GHL, up 2.77 per cent or \$0.35 to close at \$13.00 and the major decline was National Flour Mills Limited (NFM), down 4.76 per cent or \$0.12 to end the week at \$2.40.

There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 72,812 CLICO Investment Fund (CIF) units traded with a value of \$1,658,441.90. CIF's price fell 0.04 per cent or \$0.01 to \$22.61.
