EQUITY SUMMARY

The First Tier Market decreased by 43.47 per cent on a total of 561,374 shares traded compared to 993,051 shares crossing the floor in the previous week. The value of the shares traded fell by 67.12 per cent to \$5,908,837.30 from the last week's value of \$17,970,555.10. The volume leader this week was JMMB Group Limited (JMMBGL) capturing 29.99 per cent of the market activity or 168,350 shares. National Flour Mills Limited (NFM) was in second place with 17.54 per cent or 98,489 shares, followed by GraceKennedy Limited (GKC) with 12.07 per cent of the market activity or 67,750 shares traded.

The Indices ended the week in negative territory. The Composite Index slid by 0.37 per cent or 4.89 points to close at 1,301.62. The All Trinidad and Tobago Index ended at 1,747.43, a decrease of 0.40 per cent or 7.03 points. The Cross Listed Index closed at 115.67, down 0.33 per cent or 0.38 points and the Small and Medium Enterprise Index ended at 64.77 a decline of 0.66 per cent or 0.43 points. This week there was 5 stocks advancing and 11 stocks declining, while 2 stocks were at their 52 week high and 5 stocks at their 52 week low.



The major advance was NFM up 5.26 per cent or \$0.10 to close the week at \$2.00, which was its 52 week high, followed by Guardian Holdings Limited (GHL) with an increase of 0.60 per cent or \$0.12 to close at \$20.11. In third place was First Caribbean International Bank Limited (FCI) up 0.14 per cent or \$0.01 to close at \$7.05.

Guardian Media Limited (GML) was the major decline this week down 10.53 per cent or \$0.50 to close at \$4.25, its 52 week low. GKC was in second place with a decrease of 3.53 per cent or \$0.13 to close at \$3.55, Trinidad Cement Limited (TCL) followed with a decline of 2.38 per cent or \$0.05 to close at \$2.05.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market, 132,880 CLICO Investment Fund (CIF) units traded with a value of \$3,333,385.15. CIF's unit price closed at \$25.00, down 0.79 per cent or \$0.20 from last week. Also 2,000 Calypso Macro Index Fund (CALYP) units traded with a value of \$28,000.00. CALYP's unit price closed at a \$14.00, unchanged from the previous week.

On the Small and Medium Enterprise Market, CinemaOne Limited (CINE1) closed at \$4.00, a decrease of 9.09 per cent or \$0.40 from the previous week. 160 CINE1 shares traded, with a value of \$640.00. Also, 250 Endeavour Holdings Limited (EHL) shares traded this week, valued at \$3,097.50. EHL closed at \$12.39, down 0.08 per cent or \$0.01 from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week and closed at a price of US\$1.00 unchanged from last week.
