EQUITY SUMMARY

This week saw 2,137,883 shares traded on the First Tier Market an increase of 182.56 per cent on last week's total of 756,615 shares. The value of the shares traded increased by 71.75 per cent to \$27,716,082.66 from last week's value of \$16,137,266.43. NCB Financial Group Limited (NCBFG) was the volume leader this week capturing 44.17 per cent of the market activity or 944,239 shares traded followed by JMMB Group Limited (JMMBGL) with 25.06 per cent or 535,673 shares traded. In third place was Point Lisas Industrial Port Development Corporation (PLD) with 9.11 per cent or 194,745 shares traded.

The Indices ended the week in mixed territory. The Composite Index increased by 0.67 per cent or 10.03 points to close at 1,505.21. The All Trinidad and Tobago Index rose by 1.16 per cent or 21.93 points to end at 1,919.00. The Cross Listed Index closed at 147.84, down 0.19 per cent or 0.28 points. The Small and Medium Enterprise Index ended at 67.73, unchanged from last week. This week there were 9 stocks advancing and 8 stocks declining, while 6 stocks were at their 52 week high and 6 stock at their 52 week low.



First Citizens Bank Limited (FIRST) was the major advance up 8.74 per cent or \$4.09 to close the week at \$50.91, its 52 week high. In second place was PLD with an increase of 5.63 per cent or \$0.20 to close at \$3.75, followed by L.J. Williams Limited – B (LJWB), up 3.23 per cent or \$0.05 to close at \$1.60.

This week the major decline was Trinidad Cement Limited (TCL), down 4.10 per cent or \$0.08 to close at \$1.84, followed by Unilever Caribbean Limited (UCL) with a decrease of 2.49 per cent or \$0.55 to close at \$21.50, its 52 week low. In third place was West Indian Tobacco Company Limited (WCO) down by 1.90 per cent or \$0.76 to close at \$39.27.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 932,578 CLICO Investment Fund (CIF) units traded with a value of \$26,550,766.25. CIF's unit price closed at \$28.47, an increase of 0.07 per cent or \$0.02 from last week. In addition 1,000 Calypso Macro Index Fund (CALYP) units traded with a value of \$15,871.00. CALYP closed at a price of \$15.85 up 0.13 per cent or \$0.02 from the previous week.

On the Small and Medium Enterprise Market, CinemaOne Limited (CINE 1) closed the week at \$5.75 unchanged from last week with no shares traded. No Endeavour Holdings Limited (EHL) shares traded this week and it closed at \$12.65.

On the USD Equity Market, MPC Caribbean Clean Energy Limited (MPCCEL) closed at US\$1.08 with no shares traded.
