EQUITY SUMMARY

This week saw 708,357 shares traded on the First Tier Market an increase of 11.33 per cent on last week's total of 636,282 shares crossing the floor. The value of the shares traded was up by 14.46 per cent to \$17,992,116.94 from last week's value of \$15,719,739.86. West Indian Tobacco Company Limited (WCO) was the volume leader capturing 21.92 per cent of the market activity or 155,290 shares traded, followed by Trinidad Cement Limited (TCL) with 21.59 per cent or 152,944 shares traded. In third place was Massy Holdings Limited (MASSY) with 13.39 per cent of the market activity or 94,828 shares traded.

The Indices ended the week in mixed territory. The Composite Index increased by 0.13 per cent or 1.78 points to close at 1,324.89. The All Trinidad and Tobago Index ended at 1,771.66, down 0.05 per cent or 0.95 points. The Cross Listed Index rose by 0.53 per cent or 0.62 points to close at 118.71. The Small and Medium Enterprise



Index ended at 60.40, a decline of 6.11 per cent or 3.93 points from last week. This week there were 8 stocks advancing and 10 stocks declining, while 3 stock were at its 52 week high and 2 stock was at their 52 week low.

The major advance this week was TCL up 20.00 per cent or \$0.50 to close at \$3.00 which was its 52 week high. First Citizens Bank Limited (FIRST) followed, with an increase of 1.91 per cent or \$0.82 to close at \$43.85. In third place was NCB Financial Group Limited (NCBFG), up 1.48 per cent or \$0.12 to close at \$8.25.

Guardian Media Limited (GML) was the major decline, down 12.28 per cent or \$0.42 to close at \$3.00, its 52 week low. In second place was Trinidad and Tobago NGL Limited (NGL) with a decrease of 6.35 per cent or \$1.08 to close at \$15.92, followed by Angostura Holdings Limited (AHL) with a decline of 5.18 per cent or \$0.85 to close at \$15.55.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market, 28,699 CLICO Investment Fund (CIF) units traded with a value of \$729,237.74. CIF's unit price closed at \$25.45, up 0.79 per cent or \$0.20 from last week. No, Calypso Macro Index Fund (CALYP) units traded this week and closed at \$14.01, unchanged from the previous week.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) shares traded and closed the week at a price of \$4.00. Also, 100 Endeavour Holdings Limited (EHL) shares traded this week with a value of \$1,150.00. EHL share price closed at \$11.50, down 6.50 per cent or \$0.80 from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week and closed at a price of US\$1.00 unchanged from last week.
