EQUITY SUMMARY

The First Tier Market decreased by 33.99 per cent on a total of 538,962 shares traded this week compared to 816,511 shares crossing the floor in the previous week. The value of the shares traded fell by 85.08 per cent to \$5,431,975.05 from last week's value of \$36,415,484.48. The volume leader this week was JMMB Group Limited (JMMBGL) capturing 33.04 per cent of the market activity or 178,083 shares traded. In second place was One



Caribbean Media Limited (OCM) with 27.88 per cent or 150,258 shares traded, followed by West Indian Tobacco Company Limited (WCO) with 8.15 per cent of the market activity or 43,944 shares traded.

The Indices ended the week in mixed territory. The Composite Index increased by 0.003 per cent or 0.04 points to close at 1,343.16. The All Trinidad and Tobago Index ended at 1,779.51, up 0.05 per cent or 0.86 points. The Cross Listed Index declined by 0.09 per cent or 0.11 points to close at 122.68. The Small and Medium Enterprise Index ended at 55.48, down 4.25 per cent or 2.46 points from last week. This week there were 8 shares advancing and 6 shares declining, while 2 shares were at its 52 week high and 1 share at its 52 week low.

The major advance this week was OCM, up 6.52 per cent or \$0.30 to close at \$4.90, followed by Guardian Holdings Limited (GHL) with an increase of 2.28 per cent or \$0.57 to close at \$25.57. In third place was National Flour Mills Limited (NFM), up 1.86 per cent or \$0.04 to close at \$2.19.

Trinidad and Tobago NGL Limited (NGL) was the major decline this week, down 1.60 per cent or \$0.24 to close at \$14.75. Scotiabank Trinidad and Tobago Limited (SBTT) was in second place with a decrease of 1.56 per cent or \$0.86 to close at \$54.11, followed by JMMBGL with a decline of 1.10 per cent or \$0.02 to close at \$1.80.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market, 17,761 CLICO Investment Fund (CIF) units traded with a value of \$445,497.96. CIF's unit price closed at \$25.02, down 0.52 per cent or \$0.13 from last week. In addition, 80 Calypso Macro Index Fund (CALYP) units traded this week with a value of \$1,140.00. CALYP closed at \$14.25, up 0.64 per cent or \$0.09 from the previous week.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) shares traded and closed the week at a price of \$4.00, unchanged from last week. While, 125 Endeavour Holdings Limited (EHL) shares traded this week with a value of \$1,312.50. EHL's share price closed at \$10.50, down 4.55 per cent or \$0.50 from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week and closed at a price of US\$1.00 unchanged from last week.


