EQUITY SUMMARY

Trinidad and Tobago

This week saw 1,967,841 shares traded on the First Tier Market an increase of 56.80 per cent on last week's total of 1,255,018 shares crossing the floor. The value of the shares traded was up by 52.33 per cent to \$21,429,815.69 from the previous week's value of \$14,067,781.29. For the second consecutive week the volume leader was Sagicor Financial Limited (SFC) capturing 48.27 per cent of the market activity or 949,892 shares traded, followed by Trinidad Cement Limited (TCL) with 12.07 percent or 237,535 shares traded. In third place was NCB Financial Group Limited (NCBFG) with 9.72 per cent or 191,364 shares traded which has been in the top three for the past two weeks.



The Indices ended the week in positive territory. The Composite Index rose by 1.01 per cent or 13.58 points to close at 1,359.96. The All Trinidad and Tobago Index was up by 1.19 per cent or 21.35 points to end at 1,813.14. The Cross Listed Index closed at 122.31 an increase of 0.63 per cent or 0.77 points and the Small and Medium Enterprise Index ended at 99.50. This week there were 15 stocks advancing and 4 stocks declining, while 5 stocks were at their 52 week high and 4 stocks at their 52 week low.

The major advance this week was Prestige Holdings Limited (PHL) up 11.80 per cent or \$0.95 to close at \$9.00, followed by First Citizens Bank (FIRST) with an increase of 7.86 per cent or \$2.91 to close at \$39.91. In third place was TCL up 5.77 per cent or \$0.15 to close at \$2.75.

National Enterprises Limited (NEL) was the major decline, down 2.14 per cent or \$0.15 to end at \$6.85. In second place was Republic Financial Holdings Limited (RFHL), down 1.76 per cent or \$2.17 to close at \$120.83, followed by JMMB Group Limited (JMMBGL) down by 0.59 per cent or \$0.01 to close at \$1.69.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 192,049 CLICO Investment Fund (CIF) units traded with a value of \$4,389,679.24. CIF's unit price closed at \$23.00, an increase of 2.72 per cent or \$0.61 from last week. Also, 265 units in Calypso Macro Index Fund (CALYP) traded with a value of \$3,975.00. CALYP's unit price closed at \$15.00, unchanged from last week.

On the Small and Medium Enterprise Market CinemaOne Limited (CINE 1) traded 361 shares, valued at \$3,602.35 to close the week at \$9.95, unchanged from last week.

On the USD Equity Market, MPC Caribbean Clean Energy Limited (MPCCEL) closed at US\$1.00 with no shares traded.

(PR Newswire) - Trinidad Petroleum Holdings Limited ("TPHL") announced that the early tender deadline has been extended until 5:00 p.m., New York City time, on May 10, 2019 (the "Extended Early Tender Deadline") and the withdrawal deadline has been extended until 5:00 p.m., New York City time, on May 8, 2019 (the "Extended Withdrawal Deadline"), with respect to its previously announced offers to exchange any and all of its outstanding notes, originally issued by Petroleum Company of Trinidad and Tobago Limited ("Petrotrin") for newly issued debt securities of TPHL (the "Exchange Offers"), upon the terms and subject to the conditions described in the Offering Memorandum, dated April 15, 2019 (as may be amended or supplemented from time, the "Offering Memorandum"), and the related letter of transmittal (as may be amended or supplemented from time to time, the "Letter of Transmittal"), and to its solicitation of consents to certain proposed amendments to the existing indentures (the "Consent Solicitations"). On the terms and subject to the conditions set forth in the Offering Memorandum and TPHL's press release, dated April 15, 2019, Eligible Holders who validly tender Existing Notes at or prior to the Extended Early Tender Deadline will receive, for each U.S.\$1,000 principal amount of Existing Notes accepted for exchange, a combination of a principal amount of New Notes and, if the 2019 New



Notes Cap is exceeded, cash, in an amount equal to the Total Consideration (as defined in the Offering Memorandum).

TPHL also said that it has amended the minimum tender condition such that the consummation of the Exchange Offers is conditioned upon, among other things, the valid tender, without subsequent withdrawal, of at least U.S \$150 million aggregate principal amount of Existing Notes (the "Amended Minimum Tender Condition").

TPHL also stated that, in addition to the Total Consideration, Eligible Holders who validly tender Existing Notes at or prior to the Extended Early Tender Deadline will receive an additional US\$10 of cash for each U.S.\$1,000 principal amount of 2019 Notes and 2022 Notes, respectively, accepted for exchange (the "Additional Early Tender Consideration"); provided that a minimum of U.S.\$350 million 2019 Notes are validly tendered in the 2019 Notes Offer.

In addition, TPHL announced that the Expiration Date of the Exchange Offers is extended to 5:00 p.m., New York City time, on May 24, 2019, unless extended. Holders of Existing Notes that tender their Existing Notes after the Extended Early Tender Deadline but prior to the Expiration Date will receive the Exchange Consideration but not the Total Consideration or the Additional Early Tender Consideration. All other terms and conditions of the Exchange Offers remain the same.
