## **EQUITY SUMMARY**

This week saw 2,675,662 shares traded on the First Tier Market, an increase of 300.12 per cent on last week's total of \$668,723 shares crossing the floor. The value of trading rose by 97.34 per cent to \$23,487,997.20 from last week's value of \$11,902,330.73. GraceKennedy Limited (GKC) was the volume leader with 48.94 per cent of the market activity or 1,309,358 shares traded. In second place was JMMB Group Limited (JMMBGL) with 10.17 per cent or 272,153 shares traded. In third place was One Caribbean Media Limited (OCM) with 10.02 per cent or 268,042 shares traded.



The Indices ended the week in mixed territory. The Composite Index decreased by 0.09 per cent or 1.22 points to close at \$1,425.59. The All Trinidad and Tobago Index ended at \$1,918.24, down 0.26 per cent or 5.02 points. The Cross Listed Index rose by 0.32 per cent or 0.40 points to close at \$125.92. The Small and Medium Enterprise Index ended at \$38.31, unchanged when compared to the previous week. This week there were 7 shares advancing and 8 shares declining, while 3 shares were at their 52 week high and 1 share at its 52 week low.

The major advance this week was National Flour Mills Limited (NFM) up 4.40 per cent or \$0.08 to close at \$1.90. In second place was JMMBGL with an increase of 3.74 per cent or \$0.08 to close at \$2.22. Angostura Holding Limited (AHL) holds third place with an increase of 3.20 per cent or \$0.53 to close at \$17.10, which was its 52 week high.

The major decline this week was Trinidad and Tobago NGL Limited (NGL) down 5.99 per cent or \$1.05 to close at \$16.49. In second place was Agostini's Limited (AGL) with a decrease of 4.88 per cent or \$1.18 to close at \$23.01, followed by National Enterprises Limited (NEL) down 1.17 per cent or \$0.04 to close at \$3.37.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 129,609 CLICO Investment Fund (CIF) units traded with a value of \$3,415,586.33. CIF's unit price closed at \$26.80, up 0.64 per cent or \$0.17. There were 558 Calypso Macro Index Fund (CALYP) units traded with a value of \$9,207.00 and closed this week at \$16.50, up 1.73 per cent or \$0.28 from last week.

On the Small and Medium Enterprise Market, 172 Endeavour Holdings Limited (EHL) shares traded with a value of \$1,205.72. EHL shares closed at \$7.01, unchanged compared to last week. CinemaOne Limited (CINE1) ended the week at \$4.00, also unchanged from last week with no volume traded.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.90, unchanged from last week.


