EQUITY SUMMARY

Trinidad and Tobago

Trade activity decreased this week with 1,659,240 shares changing hands on the First Tier Market, down 10.88 percent on last week's volume of 1,861,897 shares. The value of shares traded however, rose 15.26 per cent from \$19,696,489.76 last week to \$22,702,265.14 this week. The volume leader this week was Scotia Investments Jamaica Limited (SIJL) with 23.49 per cent of all trades this week or 389,717 shares traded.

The Indices ended the week in positive territory. The Composite Index rose 0.08 per cent or 10.04 points to close at 1,219.94, the All Trinidad and Tobago Index increased 0.07 per cent or 1.21 points to end at 1,792.92 and the Cross Listed Index closed at 86.76, up 3.08 per cent or 2.59 points. Overall there were 8 stocks advancing and 7 stocks declining. The top performer was First Caribbean International Bank Limited (FCI), up 4.95 per cent or \$0.38 to close the week at \$8.05 and the major decline was National Flour Mills Limited (NFM), down 6.10 per cent or \$0.13 to end at \$2.00.



There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 28,056 CLICO Investment Fund (CIF) units traded with a value of \$603,146.37. CIF's price fell 2.27 per cent or \$0.50 to close at \$21.50.
