EQUITY SUMMARY

Trinidad and Tobago

The local market saw an increase in trading activity when compared to the previous week. There were 2,797,827 shares traded on the First Tier Market, which represented an increase of 72.79 per cent on last week's volume of 1,619,206 shares. The value of shares traded rose 16.39 per cent from \$21,708,540.83 to \$25,266,493.31. The volume leader was National Commercial Bank Jamaica Limited (NCBJ) with 28.45 per cent of the market or 796,063 shares traded. This week also saw 1,000 Sagicor Financial Corporation Convertible Redeemable Preference (SFCP) shares traded. The price remained unchanged at US\$1.10.

All three Indices closed the week higher. The Composite Index advanced 0.25 per cent or 2.89 points to end the week at 1,162.35, the All Trinidad and Tobago Index rose 0.01 per cent or 0.23 points to 1,970.76 and the Cross Listed Index climbed 1.62 per cent or 0.74 points to 46.45.

The major advance was NCBJ, up 5.88 per cent or \$0.10 to close the week at \$1.80 and the major decline was Jamaica Money Market Brokers Group Limited (JMMBGL), down 4.26 per cent or \$0.02 to \$0.45. The advance to decline ratio was 9 to 6.

There was no activity on the Second Tier Market. On the TTD Mutual Fund Market, 131,820 CLICO Investment Fund (CIF) units traded with a value of \$2,969,796.68. CIF's price remained unchanged at \$22.55. In addition, 4,000 Praetorian Property Mutual Fund (PPMF) units traded with a value of \$12,400.00. PPMF's price remained unchanged at \$3.10.
