EQUITY SUMMARY

Trinidad and Tobago

Trade volumes declined this week, down 37.68 per cent with 1,463,129 shares traded on the First Tier Market compared to 2,347,644 shares traded in the prior week. The value of shares traded fell 65.11 per cent to \$13,497,047.34 from last week's value of \$38,687,542.60. The volume leader this week was JMMB Group Limited (JMMBGL) with 36.44 per cent of the trades this week or 533,138 shares changing hands.

The Indices ended the week in positive territory. The Composite Index closed at 1,207.32, up 0.07 per cent or 0.86 points, the All Trinidad and Tobago Index rose marginally, up 0.002 per cent or 0.04 points to end at 1,790.06 and the Cross Listed Index climbed 0.28 per cent or 0.23 points to close at 83.68. The advance to decline ratio ended the week 9 to 7. The major advance was GraceKennedy Limited (GKC), rising 1.11 per cent



or \$0.03 to close at \$2.73 and the major decline was JMMBGL, which slipped 0.79 per cent or \$0.01 to end at \$1.25.

There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 75,141 CLICO Investment Fund (CIF) units traded with a value of \$1,690,658.16. CIF's price fell 0.04 per cent or \$0.01 to close at \$22.50. Additionally, 4,000 Praetorian Property Mutual Fund (PPMF) units traded with a value of \$12,080.00. PPMF's price remained unchanged at \$3.02.

Jul 10 - GraceKennedy Limited - GKC to acquire Consumer Brands Ltd

GraceKennedy Limited today announced that it has agreed to acquire 100 percent ownership of Consumer Brands Limited, a large player in the Jamaican distribution market. The acquisition is expected to be finalized before the end of Q3 2017.

Among the brands distributed by Consumer Brands is the Procter and Gamble (P&G) line of products which the company has distributed in Jamaica since 1992. Consumer Brands also distributes products for ten other international and local principals through chain and independent supermarkets, wholesalers, pharmacies, beauty supply outlets and convenience stores. With sales of over \$2 billion annually, the company has consistently achieved significant annual revenue growth since its establishment.

"This valuable portfolio of brands brings welcomed expansion to the range of products that we distribute in Jamaica. Our expertise in managing top tier brands and deep distribution channels make us a natural fit for this acquisition and we expect the products to continue to perform very well," said Don Wehby, Group CEO of GraceKennedy.



Consumer Brands will become a subsidiary of the GraceKennedy Group under GraceKennedy Foods. Athol Smith, who has been Managing Director of Consumer Brands, will remain with the company as an advisor during the transition period.

P&G brands are some of the most recognizable international fast moving consumer goods with household names such as Charmin, Bounty, Ariel, Downy, Tide, Always, Tampax, Pampers, Febreze, Crest and Olay among its products.

"We are very excited about this acquisition and look forward to working with P&G and all other stakeholders," Mr. Wehby said.
