## **EQUITY SUMMARY**

The First Tier Market increased by 25.36 per cent on a total of 887,979 shares traded compared to 708,357 shares crossing the floor last week. The value of the shares traded was up by 27.41 per cent to \$22,923,378.77 from last week's value of \$17,992,116.94. For the second consecutive week West Indian Tobacco Company Limited (WCO) was the volume leader capturing 35.74 per cent of the market activity or 317,334 shares traded. In second place was National Flour Mills Limited (NFM) with 13.86 per cent or 123,087 shares traded, followed by First Citizens Bank Limited (FIRST) with 10.46 per cent of the market activity or 92,887 shares traded.

The Indices ended the week in mixed territory. The Composite Index increased by 0.49 per cent or 6.53 points to close at 1,331.42. The All Trinidad and Tobago Index ended at 1,776.00, up 0.24 per cent or 4.34 points. The



Cross Listed Index rose by 1.01 per cent or 1.20 points to close at 119.91. The Small and Medium Enterprise Index ended at 59.17, a decline of 2.04 per cent or 1.23 points from last week. This week there were 11 stocks advancing and 7 stocks declining, while 4 stocks were at its 52 week high and 1 stock was at its 52 week low.

NFM was the major advance this week up 13.95 per cent or \$0.30 to close at \$2.45 which was its 52 week high. In second place was Trinidad Cement Limited (TCL) with an increase of 13.33 per cent or \$0.40 to close at \$3.40, its 52 week high, Guardian Media Limited (GML) followed up 8.33 per cent or \$0.25 to close at \$3.25.

The major decline this week was Angostura Holdings Limited (AHL), down 3.47 per cent or \$0.54 to close at \$15.01, followed by LJ Williams Limited "B" (LJWB) with a decrease of 3.33 per cent or \$0.05 to close at \$1.45. In third place was Massy Holdings Limited (MASSY) with a decline of 2.75 per cent or \$1.67 to close at \$59.00.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market, 14,630 CLICO Investment Fund (CIF) units traded with a value of \$370,695.76. CIF's unit price closed at \$25.31, down 0.55 per cent or \$0.14 from last week. 3,913 Calypso Macro Index Fund (CALYP) units traded this week with a value of \$55,777.30.CALYP's unit price closed at \$14.51, up 3.57 per cent or \$0.50 from the previous week.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) shares traded and closed the week at a price of \$4.00. Also, 200 Endeavour Holdings Limited (EHL) shares traded this week with a value of \$2,250.00. EHL share price closed at \$11.25, down 2.17 per cent or \$0.25 from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week and closed at a price of US\$1.00 unchanged from last week.
