EQUITY SUMMARY

This week saw 5,000,697 shares traded on the First Tier Market, an 87.60 per cent increase on last week's total of 2,665,684 shares crossing the floor. The value of the shares traded increased by 32.40 per cent from \$40,698,247.22 last week to \$53,882,938.13 this week. Massy Holdings Limited (MASSY) was the volume leader this week with 29.08% per cent of the market activity or 1,454,272 shares traded, followed by GraceKennedy Limited (GKC) with 26.21 per cent or 1,310,515 shares traded. JMMB Group Limited (JMMBGL) was in third place with 24.21 per cent or 1,210,555 shares traded. These shares accounted for 79.50 per cent of the shares traded this week.

The Indices ended the week in negative territory. The Composite Index decreased by 0.28 per cent or 3.77 points to close at 1,364.24. The All Trinidad and Tobago Index ended at 2,029.66 down 0.23 per cent or 4.68 points. The



Cross Listed Index fell by 0.43 per cent or 0.39 points to close at 91.29. The Small and Medium Enterprise Index ended at 40.96, down 5.67 per cent or 2.46 points from last week. This week there were 6 shares advancing and 8 shares declining, while 2 shares were at their 52 week high and 4 shares were at their 52 week low.

The major advance this week was Prestige Holdings Limited (PHL) up 6.67 per cent or \$0.40 to close at \$6.40. Unilever Caribbean Limited (UCL) was in second place with an increase of 4.44 per cent or \$0.56 to close at \$13.17. Massy Holdings Limited (MASSY) was in third place with an increase of 1.48 per cent or \$0.07 to close at \$4.80.

National Flour Mills Limited (NFM) was the major decline this week down 9.43 per cent or \$0.15 to close at \$1.44, its 52 week low. In second place was Angostura Holdings Limited (AHL) with a decrease of 5.66 per cent or \$1.50 to close at \$25.00. In third place was Guardian Holdings Limited (GHL) down 1.92 per cent or \$0.50 to close at \$25.50, its 52 week low.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 135,625 CLICO Investment Fund (CIF) units traded with a value of \$4,011,866.40. CIF's unit price closed at \$29.93, up 1.42 per cent or \$0.42 from last week. No Calypso Macro Index Fund (CALYP) units traded this week. CALYP's unit price closed at \$20.53, unchanged from last week.

On the Small and Medium Enterprise Market, 2,335 Endeavour Holdings Limited (EHL) shares traded at \$16,345.01 while no CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$7.00, down 6.67% or \$0.50 from last week, while CINE1 closed at \$6.80 unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.90, unchanged from last week.

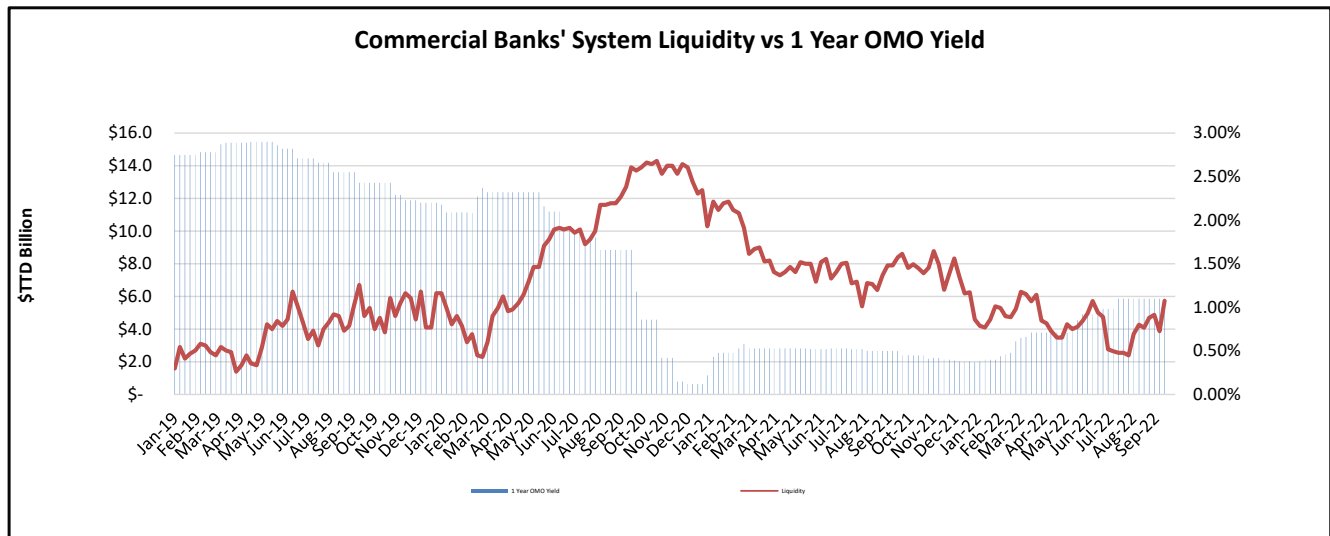
