# **Trinidad and Tobago**

The local market saw a decline in trading activity this week. A total of 1,285,613 shares crossed the floor on the First Tier Market, down 13.74 per cent on last week's volume of 1,490,391 shares. The value of shares traded decreased 78.06 per cent to \$14,846,982.05 from the previous week's value of \$67,655,892.60. The volume leader was Trinidad Cement Limited (TCL) with 37.77 per cent of all trades or 485,640 shares traded.

The Indices ended the week mixed. The Composite Index declined 0.03 per cent or 0.38 points to end the week at 1,164.85, the All Trinidad and Tobago Index dropped 0.13 per cent or 2.62 points to 2,008.78 and the Cross Listed Index rose 0.60 per cent or 0.25 points to 42.02. This week there were 7 stocks advancing and 8 declining. The major advance was Sagicor Financial Corporation (SFC) posting a 3.69 per cent gain or \$0.24 to close at \$6.74 and the major decline was L.J. Williams Limited 'A' (LJWA) which fell 10.34 per cent or \$0.03 to \$0.26.



There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market, 334,097 CLICO Investment Fund (CIF) units traded with a value of \$7,244,025.85. CIF's price rose 0.32 per cent or \$0.07 to \$21.74. In addition, 19,898 Praetorian Property Mutual Fund (PPMF) units traded with a value of \$70,637.90. There was no change in PPMF's price.

#### **Jamaica**

In Jamaica, the JSE Market Index declined 430.42 points or 0.61 per cent this week to close at 70,187.51. Trading activity resulted in 7,362,256 shares traded valued at J\$59,186,385.09. The volume leader this week was Sagicor Group Jamaica Limited (SJ) with 23.71 per cent of the market or 1,745,522 shares traded. The major advance was Desnoes and Geddes Limited (DG), up 5.41 per cent or J\$0.23 to J\$4.48 and the major decline was Kingston Wharves Limited (KW), down 16.67 per cent or J\$1.00 to J\$5.00.
