EQUITY SUMMARY

Trinidad and Tobago

A total of 699,899 shares traded on the First Tier Market this week, up 34.78 per cent on last week's volume of 519,304 shares. The value of shares traded, however, fell 10.80 per cent to \$10,652,049.94 from last week's value of \$11,942,406.57. The volume leader, for the second consecutive week, was JMMB Group Limited (JMMBGL), capturing 24.75 per cent of all trades this week or 173,204 shares traded.

All three Indices closed higher. The Composite Index increased 0.52 per cent or 5.95 points to close at 1,153.97, the All Trinidad and Tobago Index rose 0.33 per cent or 6.00 points to 1,817.43 and the Cross Listed Index climbed 1.24 per cent 0.80 points to 65.29. This week saw 9 stocks advancing and 7 stocks declining. The major advance was GraceKennedy Limited (GKC) which posted a gain of 11.68 per cent or \$0.23 to end the week at \$2.20 and the major decline was L.J. Williams 'B' Limited (LJWB), down 9.68 per cent or \$0.09 to \$0.84.



There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 52,405 CLICO Investment Fund (CIF) units traded with a value of \$1,187,178.25. CIF's price remained unchanged at \$22.65.
