EQUITY SUMMARY

The First Tier Market saw a decrease of 11.24 per cent on a total of 2,025,530 shares traded compared to 2,281,972 shares in the previous week. The value of the shares traded was down by 29.10 per cent to \$22,161,555.86 from last week's value of \$31,259,475.89. FirstCaribbean International Bank Limited (FCI) was the volume leader capturing 29.85 per cent of the market activity or 604,600 shares traded. In second place was JMMB Group Limited (JMMBGL) with 21.81 per cent or 441,764 shares traded and has been in the top three for the past six weeks, followed by NCB Financial Group Limited (NCBFG) with 10.97 per cent or 222,193 shares traded.

The Indices ended the week in mixed territory. The Composite Index rose by 0.01 per cent or 0.08 points to close at 1,468.48. The All Trinidad and Tobago Index decreased by 0.47 per cent or 8.65 points to end at 1,836.20. The Cross Listed Index closed at 149.19, up 0.82 per cent or 1.21 points. The Small and Medium Enterprise Index ended at 68.00 unchanged from last week. This week there were 9 stocks advancing and 8 stocks declining, while 6 stocks were at their 52 week high and 7 stocks at their 52 week low.

GraceKennedy Limited (GKC) was the major advance this week up 13.37 per cent or \$0.46 to close at \$3.90, L.J. Williams Limited B (LJWB) followed with an increase of 12.67 per cent or \$0.19 to close at \$1.69 its 52 week high. In third place was Trinidad and Tobago NGL Limited (NGL) up 3.81 per cent or \$0.82 to close at \$22.32.

The top three declining stocks this week ended at their 52 week low. For the second consecutive week, One Caribbean Media Limited (OCM) was the major decline, down 6.59 per cent or \$0.60 to close at \$8.50. In second place was Asna McAL Limited (AMCL) with a decrease of 4.76 per cent or \$2.50 to close at \$50.00, followed by Guardian Media Limited (GML) down by 3.85 per cent or \$0.30 to close at \$7.50.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 116,846 CLICO Investment Fund (CIF) units traded with a value of \$2,978,805.05. CIF's unit price closed at \$27.23, an increase of 4.73 per cent or \$1.23 from last week. Also, 50 units in Calypso Macro Index Fund (CALYP) traded with a value of \$1,350.00. CALYP price closed at \$15.75, unchanged from the previous week.

On the Small and Medium Enterprise Market (SME), CinemaOne Limited (CINE 1) closed the week at \$6.80, unchanged from last week with no shares traded. 3,560 shares traded in Endeavour Holdings Limited (EHL) this week with a value of \$44,500.00. EHL closed the week at a price of \$12.50, unchanged from the previous week.

(Bloomberg) - Government bonds fell around the world as a string of central banks kept their interest rates steady while one raised its benchmark. U.S. equity-index futures drifted lower with stocks in Europe, though shares in major markets remain close to record highs.

Treasuries slipped along with sovereign bonds from London to Tokyo as the monetary decisions rolled out. Sweden's central bank raised its benchmark to end half a decade of sub-zero interest rates, a move that will provide a test case for global counterparts with negative borrowing costs.
