EQUITY SUMMARY

Trinidad and Tobago

The activity on the First Tier Market increased by 0.27 per cent this week with a total of 1,678,095 shares crossing the floor compared to 1,673,654 shares in the prior week. The value of shares traded declined by 18.98 per cent to \$17,574,411.46 from the previous week's value of \$21,692,532.15. JMMB Group Limited (JMMBGL) was the volume leader capturing 24.34 per cent of the market with 408,458 shares traded followed by Trinidad Cement Limited (TCL) with 20.86% per cent or 350,000 shares. The third volume leader was National Flour Mills Limited (NFM) with 14.37 per cent of market activity or 241,130 shares.

The Indices ended the week in mixed territory. The Composite Index rose by 0.30 per cent or 3.71 points to close at 1,245.67. The All Trinidad and Tobago Index slid by 0.34 per cent or 6.06 points to end at 1,764.60 and the Cross Listed Index closed at 97.74, up 1.95 per cent or 1.87 points. This week there were 7 stocks



advancing and 6 stocks declining. For the second consecutive week JMMB Group Limited (JMMBGL) was the major advance, up 21.43 per cent or \$0.30 to close the week at \$1.70 followed by First Caribbean International Bank Limited (FCI) which posted a 1.11 per cent gain or \$0.09 to end at \$8.22. In third place was NCB Financial Group Limited (NCBFG) up 0.38 per cent or \$0.02 to end at \$5.32.

LJ Williams Limited - "A" (LJWA) was the major decline, down 12.00 per cent or \$0.03 to end at \$0.22. The second major decline was Unilever Caribbean Limited (UCL) which posted a 4.65 per cent loss or \$1.95 to end at \$40.00 followed by National Enterprises Limited (NEL) down 3.47 per cent or \$0.36 to close at \$10.00.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 24,959 CLICO Investment Fund (CIF) units traded with a value of \$535,401.04. CIF's price fell 0.33 per cent or \$0.07 to close at \$21.41.
