EQUITY SUMMARY

Trinidad and Tobago

Volumes traded on the First Tier Market this week were down on last week's volume by 73.68 per cent with a total of 589,125 shares changing hands compared to 2,237,903 shares traded in the previous week. The value of shares traded was \$8,593,878.00, down 66.42 per cent on the prior week's value of \$25,588,837.76. FirstCaribbean International Bank Limited (FCI) was the volume leader with 19.15 per cent of the market or 112,824 shares traded.

Both the Composite and All Trinidad and Tobago Indices posted declines this week while the Cross Listed Index closed higher. The Composite Index fell 0.05 per cent or 0.53 points to end at 1,164.29, the All Trinidad and Tobago Index slipped 0.19 per cent or 3.77 points to 1,937.34 and the Cross Listed Index rose 0.72 per cent or 0.37 points to 51.59. The advance to decline ratio ended the week 7 to 8. The major advance was Scotia



Investments Jamaica Limited (SIJL), registering a 3.95 per cent gain or \$0.06 to close at \$1.58 and the major decline for the second week in a row was National Flour Mills Limited (NFM), down 3.60 per cent or \$0.09 to \$2.41.

There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 398,462 CLICO Investment Fund (CIF) units traded with a value of \$9,064,471.33. CIF's price fell 0.09 per cent or \$0.02 to \$22.73. Additionally 192 units of Calypso Macro Index Fund (CALYP), which listed on the market on January 11, 2016, traded with a value of \$4,800.00. CALYP's price remained unchanged at \$25.00.
