## **EQUITY SUMMARY**

The First Tier Market increased by 292.92 per cent on a total of 5,288,842 shares crossing the floor compared to 1,346,042 shares traded in the previous week. The value of the shares traded more than tripled, up 231.13 per cent to \$47,509,176.44 from last week's value of \$14,347,690.73. For the second consecutive week JMMB Group Limited (JMMGBL) was the volume leader capturing 60.82 per cent of the market activity or 3,216,697 shares traded and has been in the top three for the past four weeks. In second place was, Trinidad and Tobago NGL Limited (NGL) with 12.68 per cent or 670,833 shares traded, followed by FirstCaribbean International Bank Limited (FCI) with 8.82 per cent or 466,642 shares traded.

The Indices ended the week in negative territory. The Composite Index decreased by 0.67 per cent or 9.38 points to close at 1,388.76. The All Trinidad and Tobago Index fell by 0.38 per cent or 6.67 points to end at 1,762.35. The Cross Listed Index closed at 137.46, down 1.19 per cent or 1.66 points. The Small and Medium



Enterprise Index ended at 84.00, unchanged from the previous week. This week there were 5 stocks advancing and 8 stocks declining, while 6 stocks were at their 52 week high and 6 stocks at their 52 week low.

The major advance was GraceKennedy Limited (GKC) up 2.25 per cent or \$0.08 to close the week at \$3.63, its 52 week high. In second place was Angostura Holdings Limited (AHL) with an increase of 0.44 per cent or \$0.07 to close at \$15.86, followed by First Citizens Bank Limited (FIRST) up 0.05 per cent or \$0.02 to close at \$40.03.

JMMBGL was the major decline this week, down 4.55 per cent or \$0.10 to close at \$2.10, followed by Sagicor Financial Corporation Limited (SFC) with a decrease of 3.25 per cent or \$0.34 to close at \$10.11. In third place was West Indian Tobacco Company Limited (WCO) down by 2.73 per cent or \$3.00 to close at \$107.00.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 698,354 CLICO Investment Fund (CIF) units traded with a value of \$16,767,057.47. CIF's unit price closed at \$24.15, unchanged from last week. Also, 334 units in Calypso Macro Index Fund (CALYP) traded with a value of \$5,110.00. CALYP price closed at \$15.50, an increase of 8.77 per cent or \$1.25 from the previous week.

On the Small and Medium Enterprise Market, CinemaOne Limited (CINE 1) closed the week at \$8.40, with no shares traded.

On the USD Equity Market, MPC Caribbean Clean Energy Limited (MPCCEL) closed at US\$1.00 with no shares traded.

## **Regional News**

• (Fitch Ratings) - Fitch Ratings has affirmed Suriname's Long Term Foreign Currency Issuer Default Rating (IDR) at 'B-'. The Rating Outlook has been revised to Negative from Stable.

The Negative Outlook reflects Fitch's expectation that large government deficits and financing needs, in part reflecting spending pressures related to elections in May 2020, will continue to lead to a rapid increase in government debt/GDP.

Trinidad and Tobago Government removed businessman Wilfred Espinet as chairman of Trinidad Petroleum Holdings Ltd (TPHL) and its subsidiaries, as part of a comprehensive restructuring of TPHL and its successor companies. He was replaced by attorney Michael Quamina who has served as the Prime Minister's attorney. Housing Development Corporation (HDC) chairman Newman George, husband of Speaker of the House of Representatives Brigid Annisette-George, will chair the Guaracara Refining Company Ltd and Paria Fuel Trading Company.



With boosting Heritage's oil production being critical to the economy, Government will find a permanent replacement for CEO Mike Wiley, who is undergoing cancer treatment in the US. Finance Minister Colm Imbert and Energy Minister Franklin Khan made these announcements at the post-Cabinet news conference at the Diplomatic Centre in St Ann's.
