EQUITY SUMMARY

Trinidad and Tobago

The activity on First Tier Market increased significantly by 237.90 per cent this week with a total of 1,770,426 shares crossing the floor compared to 523,940 shares traded in the prior week. The value of shares traded more than doubled, up 112.51 per cent to \$22,366,687.29 from the previous week's value of \$10,525,221.15. The volume leader this week was Agostini's Limited (AGL) with 25.78 per cent of the market or 456,504 shares traded followed by JMMB Group Limited (JMMBGL) with 19.45 per cent or 344,262 shares traded. In third place was NCB Financial Group Limited (NCBFG) with 16.41 per cent of market activity or 290,595 shares.

The Indices ended the week in a mixed territory. The Composite Index slid by 0.06 per cent or 0.72 points to close at 1,268.71. The All Trinidad and Tobago Index grew by 0.03 per cent or 0.51 points to end at 1,701.57, this was attributed mainly to the price increase of Massy Holdings Limited (MASSY) and Scotiabank Trinidad and Tobago Limited (SBTT). The Cross Listed Index closed at 112.78, down by 0.24 per cent or 0.27 points mainly

due to the price decrease of NCBFG shares. This week there were 6 stocks advancing and 6 stocks declining, while 2 stocks are at their 52 week high and 8 stocks at their 52 week low.

JMMBGL was the major advance, up 2.78 per cent or \$0.05 to close the week at \$1.85. In second place was MASSY with an increase of 0.62 per cent or \$0.29 to end at \$47.29, followed by Trinidad and Tobago NGL Limited up 0.33 per cent or \$0.09 to close at \$27.09.

National Flour Mills Limited (NFM) was the major decline, down 4.12 per cent or \$0.08 to end at \$1.86. In second place was Grace Kennedy Limited (GKC) with a 1.76 per cent loss or \$0.06 to end at \$3.34, followed by AGL, down by 0.91 per cent or \$0.19 to close at \$20.67.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 50,505 CLICO Investment Fund (CIF) units traded with a value of \$1,010,886.40. CIF's unit price, remained unchanged to close at \$20.00.
