EQUITY SUMMARY

Trinidad and Tobago

Market activity fell by 43.65 per cent this week as compared to the previous week. A total of 1,326,577 shares traded on the First Tier Market relative to last week's 2,353,966 shares traded. Concurrently, the value of traded shares fell by 27.96 per cent to \$6,981,248.42 from \$9,690,473.37. This week's volume leader was National Commercial Bank Limited (NCBJ), with 43.33 per cent of the total volume traded or 574,860 shares.

The Indices performance was mixed this week. The All Trinidad and Tobago Index increased 0.21 per cent or 4.15 points to 1,969.34 whereas the Cross Listed Index fell 1.24 per cent or 0.52 points to 41.48. The Composite Index remained relatively flat to end the week at 1,143.06,



Overall this week there were 7 stocks advancing and 5 declining. The week's major advance was Trinidad Cement Limited (TCL), up 11.76 per cent or \$0.24 to close at \$2.28 and the major decline was National Commercial Bank Jamaica Limited (NCBJ), which fell 6.96 per cent or \$0.08 to \$1.07. For the second week in a row, there was trading in Sagicor Financial Corporation Convertible Redeemable Preference (SFCP) shares. A total of 10,000 shares traded. The price held at US\$1.10.

There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market, 240,127 CLICO Investment Fund (CIF) units traded with a value of \$5,414,646.45. CIF's price rose 0.80 per cent or \$0.18 to \$22.68. In addition, 81,000 Praetorian Property Mutual Fund (PPMF) units traded with a value of \$280,400.00. PPMF's price remained unchanged at \$3.40.
