EQUITY SUMMARY

Trinidad and Tobago

The activity on the First Tier Market decreased by 58.09 per cent this week with a total of 1,524,654 shares crossing the floor compared to 3,637,797 shares in the prior week. The value of shares traded slid by 37.25 per cent to \$24,905,094.48 from the previous week's value of \$39,689,905.52. Guardian Holdings Limited (GHL) was the volume leader capturing 39.80 per cent of the market with 606,833 followed by JMMB Group Limited (JMMBGL) with 23.01 per cent or 350,860 shares traded, it has been in the top three for the whole month of December. In third place was Trinidad and Tobago NGL Limited (NGL) with 15.06 per cent of market activity or 229,592 shares.

The Indices ended the week in a mixed territory. The Composite Index, up by 0.34 per cent or 4.32 points to close at 1,266.35, this was mainly due to the price increases of JMMBGL and NCB Financial Group Limited (NCBFG). The All Trinidad and Tobago Index decreased by 0.18 per cent or 3.04 points to end at 1,728.75, this was derived mainly from the price reduction of NGL. The Cross Listed Index increased by 1.50 per cent or 1.60



points to end at 108.38. This week there were 7 stocks advancing and 4 stocks declining, while 1 stock is at its 52 week high and 6 stocks at their 52 week low.

JMMBGL was the major advance, up 9.27 per cent or \$0.14 to close the week at \$1.65.LJ Williams Limited "B" (LJWB) followed an increase of 2.67 per cent or \$0.02 to end at \$0.77 and in third place was NCBFG up 2.62 per cent or \$0.16 to close at \$6.27.

NGL was the major decline, down 3.88 per cent or \$1.07 to end at \$26.50, followed by Sagicor Financial Corporation (SFC) down 2.13 per cent or \$0.17 to end at \$7.83. The third major decline was National Flour Mills Limited (NFM) down 2.05 per cent or \$0.04 to close at \$1.91.

There was no activity on the Second Tier Market this week.

On the TTD Mutual Fund Market 9,952 CLICO Investment Fund (CIF) units traded with a value of \$208,992. CIF's unit price close at \$21.00 and remains unchanged from the previous week.
