EQUITY SUMMARY

This week saw 2,240,227 shares traded on the First Tier Market, an increase of 40.29 per cent on last week's total of 1,596,906 shares crossing the floor. The value of the shares traded was up 29.84 per cent to \$20,354,263.10 from the previous week's value of \$15,675,976.89. Massy Holdings Limited (MASSY) was the volume leader this week with 41.67 per cent of the market activity or 933,494 shares traded, followed by NCB Financial Group Limited (NCBFG) with 22.71 per cent of the market activity or 508,717 shares traded. In third place was GraceKennedy (GKC) with 6.77 per cent or 151,558 shares traded. These shares accounted for 71.14 per cent of the shares traded this week.

The Indices ended the week in negative territory. The Composite Index decreased by 1.39 per cent or 16.66 points to close at 1,184.90. The All Trinidad and Tobago Index ended at 1,783.25, down by 1.33 per cent or 24.04 points. The Cross Listed Index slid by 1.59 per cent or 1.23 points to close at 76.22. The Small and Medium Enterprise Index ended at 77.71 unchanged from the previous week. This week there were 8 shares advancing and 12 shares declining, while 1 share were at their 52-week high and 2 shares were at their 52-week low.



The major advance this week was Point Lisas Industrial Port Development Limited (PLD) up 5.70 per cent or \$0.20 to close at \$3.70. In second place was JMMB Group Limited (JMMBGL) with an increase of 2.19 per cent or \$0.03 to close at \$1.40, GKC followed with an increase of 1.27 per cent or \$0.05 to close at \$4.00.

LJ Williams "B" Limited (LJWB) was the major decline this week down 14.57 per cent or \$0.29 to close at \$1.70, Trinidad Cement Limited (TCL) followed with a decrease of 14.14 per cent or \$0.42 to close at \$2.55. In third place was Prestige Holdings Limited (PHL) down 7.15 per cent or \$1.00 to close at \$12.99.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 10,644 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$241,391.59. CALYP's unit price closed at \$22.75 up 0.66 per cent or \$0.15 from last week.

On the Small and Medium Enterprise Market, no Endeavour Holdings Limited (EHL) and CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$14.75 and CINE1 closed at \$6.45 both unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


