EQUITY SUMMARY

This week saw 3,786,904 shares traded on the First Tier Market, a decrease of 9.19 per cent on last week's total of 4,170,328 shares crossing the floor. The value of the shares traded was up 25.28 per cent to \$13,942,110.87 from the previous week's value of \$11,128,740.76. National Enterprises Limited (NEL) was the volume leader with 53.14 per cent of the market activity or 2,012,187 shares traded. In second place was Massy Holdings Ltd. (MASSY) with 22.72 per cent of the market activity or 860,353 shares traded, followed by National Flour Mills Limited (NFM) with 5.49 per cent or 207,748 shares traded. These shares accounted for 81.34 per cent of the shares traded this week.

The Indices ended the week in negative territory. The Composite Index decreased by 0.31 per cent or 2.97 points to close at 958.42. The All Trinidad and Tobago Index ended at 1,390.59, down 0.29 per cent or 4.01 points. The Cross Listed Index closed at 69.37, a decrease of 0.37 per cent or 0.26 points. The Small and Medium Enterprise



Index closed at 92.68, unchanged from last week. This week there were 6 shares advancing and 13 shares declining, while no share was at its 52-week high, and 3 shares were at their 52-week low.

The major advance this week was MASSY up 3.20 per cent or \$0.11 to close at \$3.55. In second place was Point Lisas Industrial Port Development Corporation Limited (PLD) up 1.20 per cent or \$0.06 to close at \$5.06, Trinidad Cement Limited (TCL) followed with an increase of 0.58 per cent or \$0.01 to close at \$1.74.

L.J. Williams Limited "B" (LJWB) was the major decline this week, down 13.79 per cent or \$0.16 to close at \$1.00, Agostini Limited (AGL) followed with a decrease of 3.23 per cent or \$2.00 to close at \$60.00, its 52 week low. In third place was The West Indian Tobacco Company Limited (WCO) down 2.30 per cent or \$0.06 to close at \$2.55.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, 45 CinemaOne Limited (CINE1) shares traded this week with a value of \$193.50, 1,808 Eric Solis Marketing Limited (SOLIS) shares traded with a value of \$7,069.28, 92 Medcorp Limited (MED) shares traded with a value of \$4,200.22 and 38 Endeavour Holdings Limited (EHL) shares traded with a value of \$661.20. CINE1's share price closed at \$4.68, SOLIS's share price closed at \$3.91, EHL share price closed at \$18.44 and MED's share price closed at \$46.01, all unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares or A.S Bryden & Sons Holdings 6.00% Class A Preference shares (ASBH6.00) traded this week. MPCCEL shares closed at US\$0.98, while ASBH6.00 shares closed at US\$1.00, both unchanged from last week.

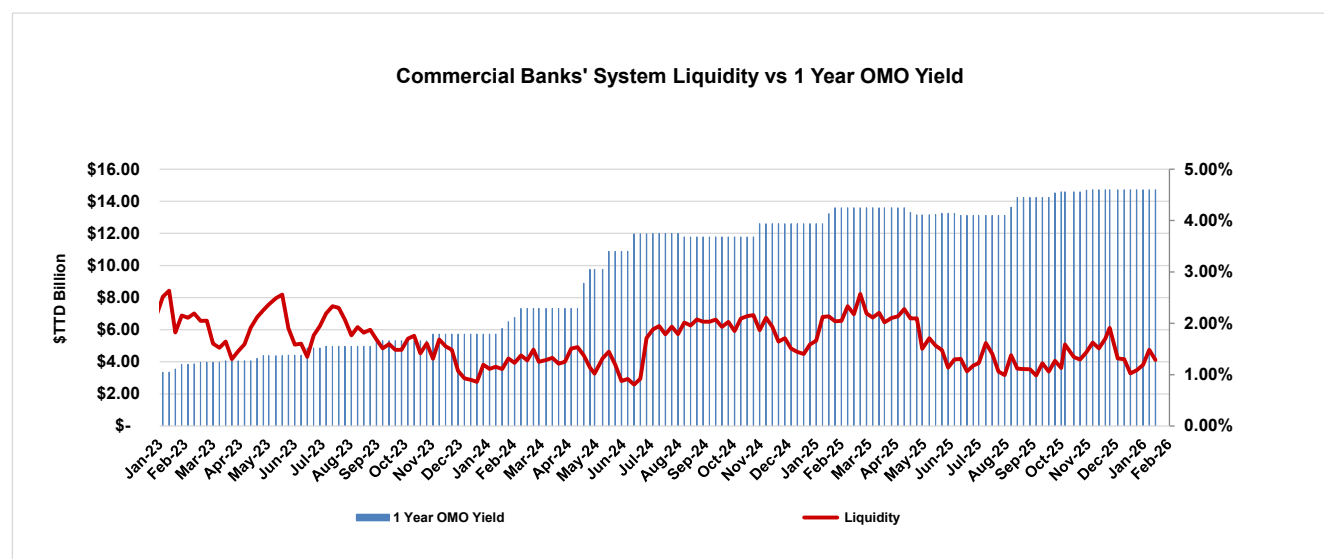
