EQUITY SUMMARY

This week saw 1,116,533 shares traded on the First Tier Market, a decrease of 70.52 per cent on last week's total of 3,786,904 shares crossing the floor. The value of the shares traded was down 34.56 per cent to \$9,123,095.11 from the previous week's value of \$13,942,110.87. Massy Holdings Ltd. (MASSY) was the volume leader with 28.43 per cent of the market activity or 317,442 shares traded. In second place was National Enterprises Limited (NEL) with 23.62 per cent of the market activity or 263,679 shares traded, followed by One Caribbean Media Limited (OCM) with 11.57 per cent or 129,144 shares traded. These shares accounted for 63.61 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 2.05 per cent or 19.62 points to close at 938.80. The All Trinidad and Tobago Index ended at 1,351.77, down 2.79 per cent or 38.82 points. The Cross Listed Index closed at 69.53, an increase of 0.23 per cent or 0.16 points. The Small and Medium Enterprise Index closed at 92.68, unchanged from last week. This week there were 8 shares advancing and 8 shares declining, while no share was at its 52-week high, and 3 shares were at their 52-week low.



The major advance this week was The West Indian Tobacco Company Limited up 10.98 per cent or \$0.28 to close at \$2.83. In second place was Guardian Media Limited (GML) up 9.68 per cent or \$0.06 to close at \$0.68, MASSY followed with an increase of 3.10 per cent or \$0.11 to close at \$3.66.

ANSA McAL Limited (AMCL) was the major decline this week, down 15.11 per cent or \$6.56 to close at \$36.85, its 52-week low. A.S. Bryden & Sons Holdings Limited (ASBH) followed with a decrease of 9.09 per cent or \$0.15 to close at \$1.50. In third place was Scotiabank Trinidad & Tobago Limited (SBTT) down 5.72 per cent or \$2.76 to close at \$45.49.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) shares traded this week. 57 Eric Solis Marketing Limited (SOLIS) shares traded with a value of \$227.37, 15 Medcorp Limited (MED) shares traded with a value of \$675.00 and 12 Endeavour Holdings Limited (EHL) shares traded with a value of \$220.80. CINE1's share price closed at \$4.68, SOLIS's share price closed at \$3.91, EHL share price closed at \$18.44 and MED's share price closed at \$46.01, all unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares or A.S Bryden & Sons Holdings 6.00% Class A Preference shares (ASBH6.00) traded this week. MPCCEL shares closed at US\$0.98, while ASBH6.00 shares closed at US\$1.00, both unchanged from last week.


