EQUITY SUMMARY

This week saw 1,573,053 shares traded on the First Tier Market, a decrease of 27.03 per cent on last week's total of 2,155,651 shares crossing the floor. The value of the shares traded was up 210.56 per cent to \$29,075,900.39 from the previous week's value of \$9,362,451.06. Massy Holdings Limited (MASSY) was the volume leader this week with 23.19 per cent of the market activity or 364,835 shares traded, followed by Ansa McAL Limited (AMCL) with 21.41 per cent of the market activity or 336,823 shares traded. In third place was Trinidad and Tobago NGL Limited (NGL) with 20.03 per cent or 315,046 shares traded. These shares accounted for 64.63 per cent of the shares traded this week.



The Indices ended the week in mixed territory. The Composite Index increased by 0.19 per cent or 2.05 points to close at 1,079.12. The All Trinidad and Tobago Index ended at 1,587.22, up by 0.28 per cent or 4.44 points. The Cross Listed Index decreased by 0.09 per cent or 0.07 points to close at 74.93. The Small and Medium Enterprise Index closed at 92.14 down 0.48 per cent or 0.44 points. This week there were 9 shares advancing and 7 shares declining, while 1 share was at its 52-week high, and 2 shares were at their 52-week low.

The major advance this week was the L.J Williams Limited "B" (LJWB) up 12.86 per cent or \$0.09 to close at \$0.79. In second place was First Citizens Group Financial Holdings Limited (FCGFH) with an increase of 2.84 per cent or \$1.18 to close at \$42.69. In third place was Point Lisas Industrial Port Development Corporation Limited (PLD) up 2.50 per cent or \$0.08 to close at \$3.28.

Angostura Holdings Limited (AHL) was the major decline this week down 4.92 per cent or \$0.73 to close at \$14.12. Prestige Holdings Limited (PHL) followed with a decrease of 2.65 per cent or \$0.30 to close at \$11.00. In third place was JMMB Group Limited (JMMBGL) down 1.85 per cent or \$0.02 to close at \$1.06.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 1,798 Calypso Macro Index Fund (CALYP) units traded this week, with a value of \$42,460.78. CALYP's unit price closed at \$23.60, a decrease of 0.30 per cent or \$0.07.

On the Small and Medium Enterprise Market, 100 CinemaOne Limited (CINE1) shares traded with a value of \$550.00 and 300 Endeavour Holdings Limited (EHL) shares traded this week with a value of \$5,453.25. 14 Eric Solis Marketing Limited (SOLIS) shares traded this week with a value of \$59.64. SOLIS share price closed at \$4.25 and EHL's share price closed at \$18.00, both unchanged from last week.CINE1's share price closed at \$5.50, a decrease of 6.78 per cent or \$0.40.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


