## EQUITY SUMMARY

This week saw 3,056,916 shares traded on the First Tier Market, an increase of 567.37 per cent on last week's total of 458,057 shares crossing the floor. The value of the shares traded was up 24.74 per cent to \$12,429,361.23 from the previous week's value of \$9,964,545.63. Trinidad and Tobago NGL Limited (NGL) was the volume leader this week with 37.06 per cent of the market activity or 1,132,854 shares traded, followed by National Enterprises Ltd (NEL) with 30.73 per cent of the market activity or 939,265 shares traded. In third place was National Flour Mills Limited (NFM) with 10.90 per cent or 333,282 shares traded. These shares accounted for 78.69 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index increased by 0.24 per cent or 2.27 points to close at 950.66. The All Trinidad and Tobago Index ended at 1,379.17, up 0.44 per cent or 6.04 points. The Cross Listed Index closed at 68.85, a decrease of 0.38 per cent or 0.26 points. The Small and Medium Enterprise Index closed at 94.06 down 0.19 per cent or 0.18 points. This week there were 9 shares advancing and 9 shares declining, while 2 shares were at its 52-week high, and 3 shares were at their 52-week low.



The major advance this week was NEL up 11.43 per cent or \$0.20 to close at \$1.95. In second place was L.J. Williams Limited "B" (LJWB) up 7.27 per cent or \$0.08 to close at \$1.18, Prestige Holdings Limited (PHL) followed with an increase of 6.31 per cent or \$0.83 to close at \$13.98.

JMMB Group Limited (JMMBGL) declined by 3.80 per cent or \$0.03 to close at \$0.76, Unilever Caribbean Limited (UCL) followed with a decrease of 1.69 per cent or \$0.024 to close at \$14.00. In third place was The West Indian Tobacco Limited (WCO) down 0.76 per cent or \$0.02 to close at \$2.62.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) or Medcorp Limited (MED) shares traded this week. 4,341 Endeavour Holdings Limited (EHL) shares traded with a value of \$80,048.04 and 10 Eric Solis Marketing Limited (SOLIS) shares traded with a value of \$39.00. CINE1's share price closed at \$4.68, MED share price closed at \$48.00 and SOLIS's share price closed at \$3.90 all unchanged from last week. EHL share price closed at \$18.44, down 0.32 per cent or \$0.06.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) or A.S Bryden & Sons Holdings 6.00% Class A Preference shares (ASBH6.00) shares traded this week. MPCCEL shares closed at US\$0.98, while ASBH6.00 shares closed at US\$1.00, both unchanged from last week.

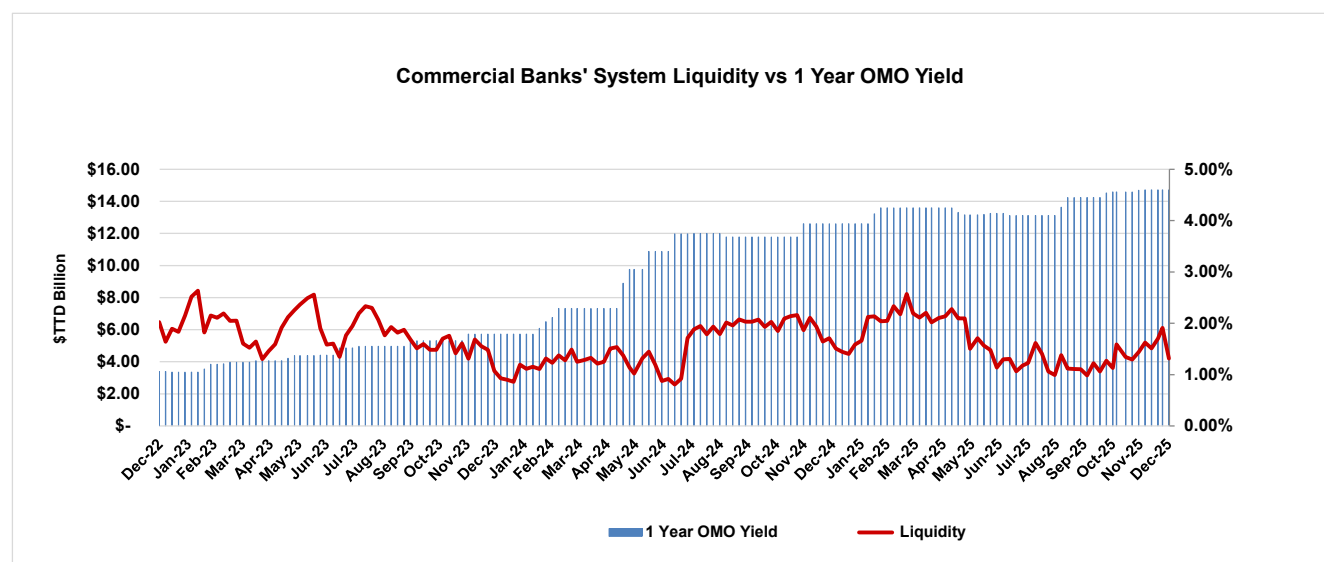
