EQUITY SUMMARY

This week saw 1,233,056 shares traded on the First Tier Market, a decrease of 50.66 per cent on last week's total of 2,498,877 shares crossing the floor. The value of the shares traded was down 25.31 per cent to \$7,557,711.51 from the previous week's value of \$10,119,045.83. NCB Financial Group Limited (NCBFG) was the volume leader with 31.87 per cent of the market activity or 392,935 shares traded. In second place was Massy Holdings Ltd (MASSY) with 15.75 per cent of the market activity or 194,244 shares traded, followed by Trinidad and Tobago NGL Limited (NGL) with 15.20 per cent or 187,414 shares traded. These shares accounted for 62.82 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index increased by 0.82 per cent or 7.82 points to close at 964.34. The All Trinidad and Tobago Index ended at 1,402.45, up 1.16 per cent or 16.08 points. The Cross Listed Index closed at 69.31, a decrease of 0.23 per cent or 0.16 points. The Small and Medium Enterprise Index closed at 92.68, unchanged from last week. This week there were 7 shares advancing and 13 shares declining, while 1 share was at its 52-week high, and 2 shares were at their 52-week low.

The major advance this week was NGL up 71.07 per cent or \$1.99 to close at \$4.79, its 52-week high. In second place was Point Lisas Industrial Port Development Corporation Limited (PLD) up 11.96 per cent or \$0.55 to close at \$5.15, National Enterprises Limited (NEL) followed with an increase of 11.46 per cent or \$0.22 to close at \$2.14.

Guardian Media Limited (GML) declined by 8.82 per cent or \$0.06 to close at \$0.62, The West Indian Tobacco Company Limited (WCO) followed with a decrease of 8.06 per cent or \$0.22 to close at \$2.51, its 52-week low. In third place was National Flour Mills Limited (NFM) down 5.00 per cent or \$0.08 to close at \$1.52.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1), Eric Solis Marketing Limited (SOLIS) or Medcorp Limited (MED) shares traded this week. 14 Endeavour Holdings Limited (EHL) shares traded with a value of \$257.60. CINE1's share price closed at \$4.68, SOLIS's share price closed at \$3.91, EHL share price closed at \$18.44 and MED's share price closed at \$46.01, all unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) while 7,000 A.S Bryden & Sons Holdings 6.00% Class A Preference shares (ASBH6.00) shares traded with a value of USD \$7,000.00. MPCCEL shares closed at US\$0.98, while ASBH6.00 shares closed at US\$1.00, both unchanged from last week.


