## EQUITY SUMMARY

This week saw 1,705,082 shares traded on the First Tier Market, a decrease of 44.22 per cent on last week's total of 3,056,916 shares crossing the floor. The value of the shares traded was down 29.96 per cent to \$8,705,315.02 from the previous week's value of \$12,429,361.23. For the second consecutive week Trinidad and Tobago NGL Limited (NGL) was the volume leader with 42.46 per cent of the market activity or 724,036 shares traded. In second place was Massy Holdings Ltd (MASSY) with 12.86 per cent of the market activity or 219,313 shares traded, followed by National Flour Mills Limited (NFM) with 11.79 per cent or 200,994 shares traded. These shares accounted for 67.11 per cent of the shares traded this week.

The Indices ended the week in positive territory. The Composite Index increased by 0.55 per cent or 5.19 points to close at 955.85. The All Trinidad and Tobago Index ended at 1,386.08, up 0.50 per cent or 6.91 points. The Cross Listed Index closed at 69.32, an increase of 0.68 per cent or 0.47 points. The Small and Medium Enterprise Index rose by 0.01 per cent or 0.01 point to closed at 94.07. This week there were 12 shares advancing and 8 shares declining, while 1 share was at its 52-week high, and 2 shares were at their 52-week low.

The major advance this week was National Enterprises Limited (NEL) up 28.72 per cent or \$0.56 to close at \$2.51. In second place was JMMB Group Limited (JMMBGL) up 10.53 per cent or \$0.08 to close at \$0.84, First Citizens Group Financial Holdings Limited (FCGFH) followed with an increase of 5.63 per cent or \$1.92 to close at \$36.01.



Point Lisas Industrial Port Development Corporation Limited (PLD) declined by 13.04 per cent or \$0.60 to close at \$4.00, Prestige Limited (PHL) followed with a decrease of 12.30 per cent or \$1.72 to close at \$12.26. In third place was A.S. Bryden & Sons Holdings Limited (ASBH) down 9.95 per cent or \$0.19 to close at \$1.72.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) or Medcorp Limited (MED) shares traded this week. 52 Endeavour Holdings Limited (EHL) shares traded with a value of \$958.88 and 3,169 Eric Solis Marketing Limited (SOLIS) shares traded with a value of \$12,370.60. CINE1's share price closed at \$4.68, MED's share price closed at \$48.00 and EHL share price closed at \$18.44 all unchanged from last week. SOLIS's share price closed at \$3.91, up 0.26 per cent or \$0.01.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) or A.S Bryden & Sons Holdings 6.00% Class A Preference shares (ASBH6.00) shares traded this week. MPCCEL shares closed at US\$0.98, while ASBH6.00 shares closed at US\$1.00, both unchanged from last week.

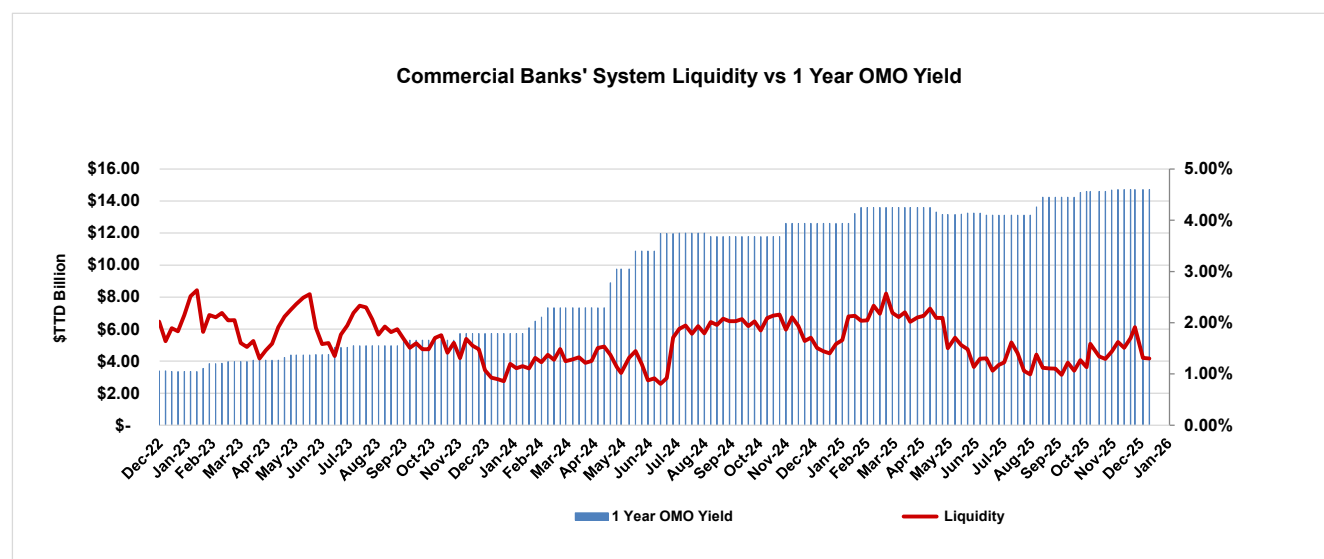
