## **EQUITY SUMMARY**

This week saw 2,357,746 shares traded on the First Tier Market, a decrease of 21.22 per cent on last week's total of 2,992,810 shares crossing the floor. The value of the shares traded decreased by 69.46 per cent to \$10,248,560.35 from the previous week's value of \$33,554,265.68. JMMB Group Limited (JMMBGL) was the volume leader this week with 46.07 per cent of the market activity or 1,086,308 shares traded. In second place was Massy Holdings Limited (MASSY) with 26.39 per cent or 622,201 shares traded, followed by National Enterprises Limited (NEL) with 8.46 per cent or 199,482 shares traded. These shares accounted for 80.92 per cent of the shares traded this week.

The Indices ended the week in negative territory. The Composite Index decreased by 0.20 per cent or 2.65 points to close at 1,328.71. The All Trinidad and Tobago Index ended at 1,998.05 down 0.09 per cent or 1.71 points. The Cross Listed Index decreased by 0.59 per cent or 0.51 points to close at 85.73. The Small and Medium Enterprise Index ended at 50.72, down 0.37 per cent or 0.19 from last week. This week there were 5 shares advancing and 11 shares declining, while 3 share were at their 52 week high and 4 shares were at their 52 week low.



The major advance this week was Agostini's Limited (AGL) up 8.00 per cent or \$4.00 to close at \$54.00, followed by ANSA Merchant Bank Limited (AMBL) with an increase of 2.27 per cent or \$1.00 to close at \$45.00. MASSY was in third place with an increase of 1.11 per cent or \$0.05 to close at \$4.55.

Guardian Media Limited (GML) was the major decline this week down 14.97 per cent or \$0.44 to close at \$2.50. In second place was Once Caribbean Media Limited (OCM) with a decrease of 9.09 per cent or \$0.30 to close at \$3.00 followed by National Enterprises Limited (NEL) down 4.76 per cent or \$0.17 to close at \$3.40.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 145,000 Eppley Caribbean Fund Limited SCC Development Fund (CPFD) units traded at a value of \$102,950.00. 431 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$9,051.00. CPFD's unit price closed at \$0.71, up 4.41 percent or 0.03 from last week. CALYP's unit price closed at \$21.00, unchanged from last week.

On the Small and Medium Enterprise Market, no Endeavour Holdings Limited (EHL) shares traded while 102 CinemaOne Limited (CINE1) shares traded with a value of \$816.00. EHL's share price closed at \$8.75, unchanged from last week and CINE1 closed at \$8.00, down 2.44 per cent or \$0.20 from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.90, unchanged from last week.


