EQUITY SUMMARY

This week saw, 908,833 shares traded on the First Tier Market, an increase of 25.32 per cent on last week's total of 725,197 shares crossing the floor. The value of the shares traded was up 130.26 per cent to \$21,099,536.93 from the previous week's value of \$9,163,334.27. Massy Holdings Limited (MASSY) was the volume leader this week with 32.05 per cent of the market activity or 291,287 shares traded, followed by ANSA McAL Limited (AMCL) with 22.07 per cent of the market activity or 200,611 shares traded. In third place was First Caribbean International Bank Limited (FCI) with 11.89 per cent or 108,088 shares traded. These shares accounted for 66.02 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index increased by 2.13 per cent or 23.74 points to close at 1,139.58. The All Trinidad and Tobago Index ended at 1,712.93, up by 1.63 per cent or 27.53 points. The Cross Listed Index rose by 3.89 per cent or 2.76 points to close at 73.64. The Small and Medium Enterprise Index ended at 86.35, down by 0.74 per cent or 0.64 points from last week. This week there were 10 shares advancing and 7 shares declining, while 3 shares were at its 52-week high and 3 were at their 52-week low.



The major advance this week was GraceKennedy Limited (GKC) up 17.88 per cent or \$0.59 to close at \$3.89. In second place was First Citizens Group Financial Holdings Limited (FCGFH) with an increase of 6.75 per cent or \$2.87 to close at \$45.37. ANSA McAL Limited (AMCL) followed with an increase of 5.31 per cent or \$3.20 to close at \$63.50, its 52-week high.

Point Lisas Industrial Port Development Corporation Limited (PLD) was the major decline this week down 8.82 per cent or \$0.30 to close at \$3.10. MASSY followed with a decrease of 3.04 per cent or \$0.12 to close at \$3.83, its 52-week low. In third place was National Enterprises Limited (NEL) down 1.53 per cent or \$0.05 to close at \$3.21.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 1,738 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$41,196.00. CALYP's unit price closed at \$23.70, the same as last week.

On the Small and Medium Enterprise Market, 2,000 CinemaOne Limited (CINE1) shares traded at a value of \$11,800.00, while no Endeavour Holdings Limited (EHL) shares traded this week. CINE1 was down 8.53 per cent or \$0.55 to close at \$5.90, while EHL's share price closed at \$16.70, unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


