EQUITY SUMMARY

This week saw, 813,991 shares traded on the First Tier Market, an decrease of 10.44 per cent on last week's total of 908,833 shares crossing the floor. The value of the shares traded was down 47.84 per cent to \$11,005,206.75 from the previous week's value of \$21,099,536.93. Massy Holdings Limited (MASSY) was the volume leader this week with 32.80 per cent of the market activity or 267,020 shares traded, followed by GraceKennedy Limited (GKC) with 20.42 per cent of the market activity or 166,256 shares traded. In third place was ANSA McAL Limited (AMCL) with 12.29 per cent or 100,035 shares traded. These shares accounted for 65.52 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 1.65 per cent or 18.76 points to close at 1,120.82. The All Trinidad and Tobago Index ended at 1,686.35, down by 1.55 per cent or 26.58 points. The Cross Listed Index fell by 1.98 per cent or 1.46 points to close at 72.18. The Small and Medium Enterprise Index ended at 87.78, down by 1.66 per cent or 1.43 points from last week. This week there were 2 shares advancing and 11 shares declining, while 3 shares were at its 52-week high and 2 were at their 52-week low.



The major advance this week was Point Lisas Industrial Port Development Corporation (PLD) up 5.81 per cent or \$0.18 to close at \$3.28. In second place was Guardian Holdings Limited (GHL) with an increase of 1.09 per cent or \$0.17 to close at \$15.75.

Trinidad Cement Limited (TCL) was the major decline this week down 11.67 per cent or \$0.35 to close at \$2.65. JMMB Group Limited (JMMBGL) followed with a decrease of 8.33 per cent or \$0.10 to close at \$1.10. In third place was Unilever Caribbean Limited (UCL) down 5.44 per cent or \$0.61 to close at \$10.60.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 12,921 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$306,689.85. CALYP's unit price closed at \$24.25, up 2.32 per cent or \$0.55 from last week.

On the Small and Medium Enterprise Market, 340 Endeavour Holdings Limited (EHL) shares traded at a value of \$5,780.00, while no CinemaOne Limited (CINE1) shares traded this week. EHL was up 1.80 per cent or \$0.30 to close at \$17.00, while CINE1's share price closed at \$5.90, unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


