EQUITY SUMMARY

This week saw, 688,677 shares traded on the First Tier Market, an increase of 0.16 per cent on last week's total of 687,561 shares crossing the floor. The value of the shares traded was up 87.44 per cent to \$8,754,898.60 from the previous week's value of \$4,670,772.60. MASSY Holdings Limited (MASSY) was the volume leader this week with 45.80 per cent of the market activity or 315,402 shares traded, followed by JMMB Group Limited (JMMBGL) with 13.01 per cent of the market activity or 89,621 shares traded. In third place was National Enterprises Limited



(NEL) with 8.52 per cent or 58,672 shares traded. These shares accounted for 67.33 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 1.97 per cent or 22.44 points to close at 1,114.69. The All Trinidad and Tobago Index ended at 1,677.75, down by 2.37 per cent or 40.74 points. The Cross Listed Index fell by 0.54 per cent or 0.39 points to close at 71.69. The Small and Medium Enterprise Index ended at 86.99 up 10.25 per cent or 8.09 points. This week there were 4 shares advancing and 14 shares declining, while 3 shares were at their 52-week high and 3 share were at their 52-week low.

The major advance this week was Angostura Holdings Limited (AHL) up 5.76 per cent or \$0.98 to close at \$18.00. In second place was Ansa McAL Limited (AMCL) with an increase of 5.13 per cent or \$3.04 to close at \$62.29, its 52 week high, JMMBGL followed with an increase of 2.46 per cent or \$0.03 to close at \$1.25.

Trinidad and Tobago NGL Limited (NGL) was the major decline this week down 8.87 per cent or \$0.688 to close at \$6.99, Republic Financial Holdings Limited (RFHL) followed with a decrease of 8.55 per cent or \$9.92 to close at \$106.06, its 52 week low. In third place was Guardian Holdings Limited (GHL) down 7.69 per cent or \$1.30 to close at \$15.60.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 14 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$336.00. CALYP's unit price closed at \$23.03 unchanged from last week.

On the Small and Medium Enterprise Market, 2,256 Endeavour Holdings Limited (EHL) traded at a value of \$37,675.20, while no CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$16.70 up 11.33 per cent or \$1.70, while CINE1 closed at \$6.45, unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.

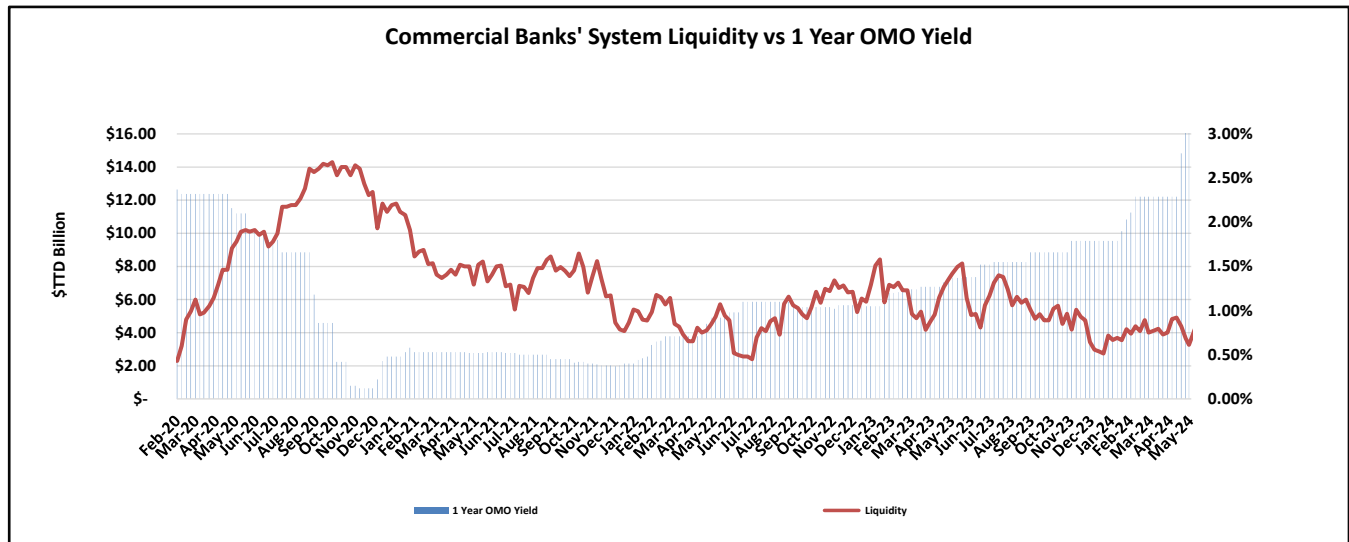
