EQUITY SUMMARY

This week saw, 759,521 shares traded on the First Tier Market, an increase of 10.29 per cent on last week's total of 688,677 shares crossing the floor. The value of the shares traded was up 13.27 per cent to \$9,916,689.94 from the previous week's value of \$8,754,898.60. Unilever Caribbean Limited (UCL) was the volume leader this week with 42.61 per cent of the market activity or 323,595 shares traded, followed by NCB Financial Group Limited (NCBFG) with 13.26 per cent of the market activity or 100,732 shares traded. In third place was JMMB Group Limited (JMMBGL) with 8.57 per cent or 65,113 shares traded. These shares accounted for 64.44 per cent of the shares traded this week.

The Indices ended the week in positive territory. The Composite Index increased by 0.92 per cent or 10.31 points to close at 1,125.00. The All Trinidad and Tobago Index ended at 1,679.64, up by 0.11 per cent or 1.89 points. The Cross Listed Index rose by 3.78 per cent or 2.71 points to close at 74.40. The Small and Medium Enterprise Index ended at 86.99, unchanged from last week. This week there were 7 shares advancing and 11 shares declining, while 1 share was at its 52-week high and 3 shares were at their 52-week low.



The major advance this week was NCBFG up 14.81 per cent or \$0.40 to close at \$3.10. In second place was The West Indian Tobacco Company Limited (WCO) with an increase of 4.06 per cent or \$0.39 to close at \$10.00, Trinidad and Tobago NGL Limited (NGL) followed with an increase of 2.58 per cent or \$0.18 to close at \$7.17.

Unilever Caribbean Limited (UCL) was the major decline this week down 5.83 per cent or \$0.69 to close at \$11.15, LJ Williams B Limited (LJWB) followed with a decrease of 4.62 per cent or \$0.09 to close at \$1.86. In third place was National Flour Mills Limited (NFM) down 4.44 per cent or \$0.10 to close at \$2.15.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 1,640 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$37,864.50. CALYP's unit price closed at \$23.05 up 0.09 per cent or \$0.02 from last week.

On the Small and Medium Enterprise Market, no Endeavour Holdings Limited (EHL) and CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$16.70 and CINE1 closed at \$6.45, both unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.

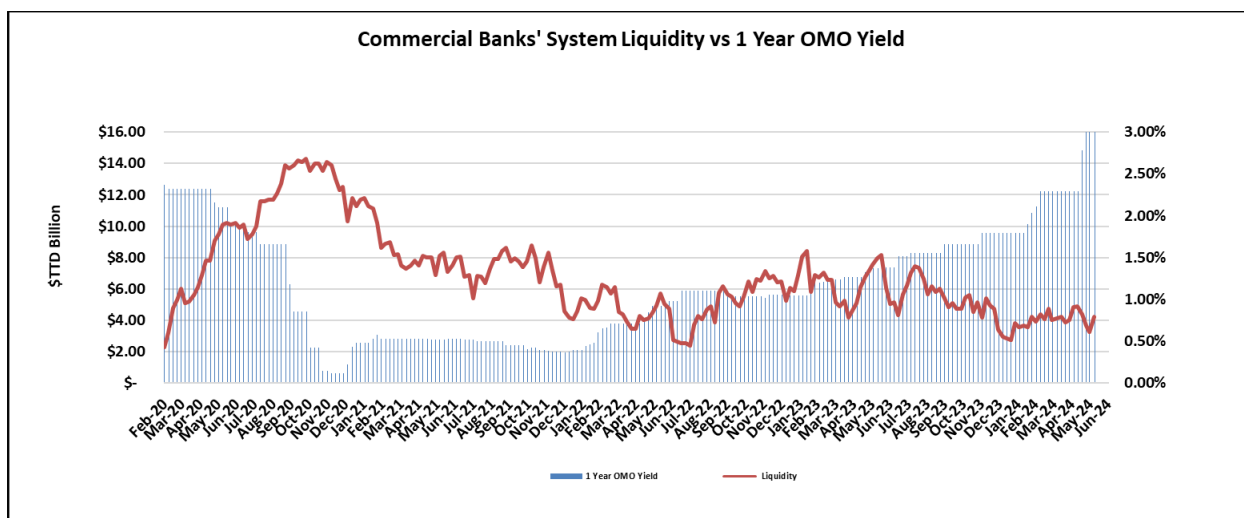
