EQUITY SUMMARY

This week saw 972,294 shares traded on the First Tier Market, a decrease of 69.97 per cent on last week's total of 3,237,416 shares crossing the floor. The value of the shares traded was down 78.54 per cent to \$8,345,284.22 from the previous week's value of \$38,892,465.78. NCB Financial Group Limited (NCBFG) was the volume leader with 33.11 per cent of the market activity or 321,944 shares traded. In second place was Trinidad and Tobago NGL Limited (NGL) with 30.49 per cent of the market activity or 296,404 shares traded, followed by Massy Holdings Ltd. (MASSY) with 10.15 per cent or 98,734 shares traded. These shares accounted for 73.75 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index increased by 0.64 per cent or 5.93 points to close at 930.72. The All Trinidad and Tobago Index ended at 1,339.74, up 0.99 per cent or 13.08 points. The Cross Listed Index fell by 0.36 per cent or 0.25 points to close at 69.01. The Small and Medium Enterprise Index closed at 91.16, unchanged from last week. This week there were 9 shares advancing and 9 shares declining, while 3 shares were at its 52-week high, and 3 shares were at their 52-week low.



The major advance this week was National Enterprises Limited (NEL) up 38.87 per cent or \$1.03 to close at \$3.68, its 52-week high. In second place was NGL up 20.41 per cent or \$1.59 to close at \$9.38, Point Lisas Industrial Port Development Corporation Limited (PLD) followed with an increase of 6.78 per cent or \$0.40 to close at \$6.30, both closed at their 52-week high.

Guardian Media Limited (GML) was the major decline this week, down 4.41 per cent or \$0.03 to close at \$0.65, One Caribbean Media Limited (OCM) followed with a decrease of 3.70 per cent or \$0.05 to close at \$1.30. In third place was Trinidad Cement Limited (TCL) down 3.55 per cent or \$0.06 to close at \$1.63, its 52-week low.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) shares traded while 30 Eric Solis Marketing Limited (SOLIS) shares traded with a value of \$120.00. 137 Medcorp Limited (MED) shares traded with a value of \$6,028.00 and 5 Endeavour Holdings Limited (EHL) shares traded with a value of \$89.50. CINE1's share price closed at \$4.68 while EHL's share price closed at \$18.40. SOLIS's share price closed at \$3.91 and MED's share price closed at \$44.00. All unchanged from last week


