EQUITY SUMMARY

This week saw 1,209,859 shares traded on the First Tier Market, a decrease of 54.93 per cent on last week's total of 2,684,460 shares crossing the floor. The value of the shares traded decreased by 34.98 per cent to \$18,660,791.42 from the previous week's value of \$28,700,200.95. National Enterprises Limited (NEL) was the volume leader this week with 31.68 per cent of the market activity or 383,299 shares traded. In second place was Massy Holdings Limited (MASSY) with 24.04 per cent or 290,805 shares traded, followed by Trinidad and Tobago NGL Limited (NGL) with 8.29 per cent or 100,293 shares traded. These shares accounted for 64.01 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index increased by 0.14 per cent or 1.85 points to close at 1,329.69. The All Trinidad and Tobago Index ended at 1,978.05 down 0.26 per cent or 5.14 points. The Cross Listed Index rose by 1.48 per cent or 1.30 points to close at 89.00. The Small and Medium Enterprise Index ended at 61.52 unchanged from last week. This week there were 11 shares advancing and 7 shares declining, while 5 shares were at their 52-week high and 3 shares were at their 52-week low.



The major advance this week was FirstCaribbean International Bank Ltd (FCI) up 8.01 per cent or \$0.53 to close at \$7.15, its 52-week high followed by One Caribbean Media Limited (OCM) with an increase of 5.71 per cent or \$0.20 to close at \$3.70. Prestige Holdings Limited (PHL) was in third place with an increase of 3.31 per cent or \$0.24 to close at \$7.50, its 52-week high.

West Indian Tobacco Company Limited (WCO) was the major decline this week down 8.00 per cent or \$1.48 to close at \$17.03, its 52-week low. In second place was JMMBGL Group Limited (JMMBGL) with a decrease of 7.41 per cent or \$0.14 to close at \$1.75, followed by National Flour Mills Limited (NFM) down 5.66 per cent or \$0.09 to close at \$1.50.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market 230 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$5,245.00. CALYP's unit price closed at \$22.52, an increase of \$1.71 or 8.22 per cent from last week.

On the Small and Medium Enterprise Market, no Endeavour Holdings Limited (EHL) nor CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$11.00, unchanged from last week while CINE1 closed at \$7.90, unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


