EQUITY SUMMARY

This week saw 4,654,283 shares traded on the First Tier Market, an increase of 554.30 per cent on last week's total of 711,333 shares crossing the floor. The value of the shares traded increased by 279.41 per cent to \$28,858,343.73 from the previous week's value of \$7,606,111.60. Massy Holdings Limited (MASSY) was the volume leader this week with 41.79 per cent of the market activity or 1,945,256 shares traded. In second place was National Enterprises Limited (NEL) with 40.71 per cent or 1,894,955 shares traded, followed by JMMB Group Limited (JMMBGL) with 4.59 per cent or 213,605 shares traded. These shares accounted for 87.10 per cent of the shares traded this week.

The Indices ended the week in positive territory. The Composite Index increased by 0.50 per cent or 6.56 points to close at 1,327.09. The All Trinidad and Tobago Index ended at 1,992.56 up 0.04 per cent or 0.76 points. The Cross Listed Index rose by 2.11 per cent or 1.78 points to close at 86.08. The Small and Medium Enterprise Index ended at 61.52 unchanged from last week. This week there were 13 shares advancing and 6 shares declining, while 4 shares were at their 52-week high and 4 shares were at their 52-week low.



The major advance this week was Trinidad Cement Limited (TCL) up 10.80 per cent or \$0.38 to close at \$3.90, followed by FirstCaribbean International Bank Limited (FCI) with an increase of 4.77 per cent or \$0.30 to close at \$6.59. Prestige Holdings Limited (PHL) was in third place with an increase of 3.05 per cent or \$0.21 to close at \$7.10, its 52 week high.

The West Indian Tobacco Company Limited was the major decline this week down 5.00 per cent or \$0.98 to close at \$18.63, its 52 week low. In second place was NEL with a decrease of 3.85 per cent or \$0.15 to close at \$3.75, followed by JMMBGL down 2.78 per cent or \$0.05 to close at \$1.75, its 52 week low.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market 706 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$15,026.91. CALYP's unit price closed at \$20.60, a decrease of \$0.90 or 4.19 per cent from last week.

On the Small and Medium Enterprise Market, 581 Endeavour Holdings Limited (EHL) shares traded at a value of \$6,391.00 while 1000 CinemaOne Limited (CINE1) shares traded this week at a value of \$7,900.00. EHL's share price closed at \$11.00, unchanged from last week while CINE1 closed at \$7.90, unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.

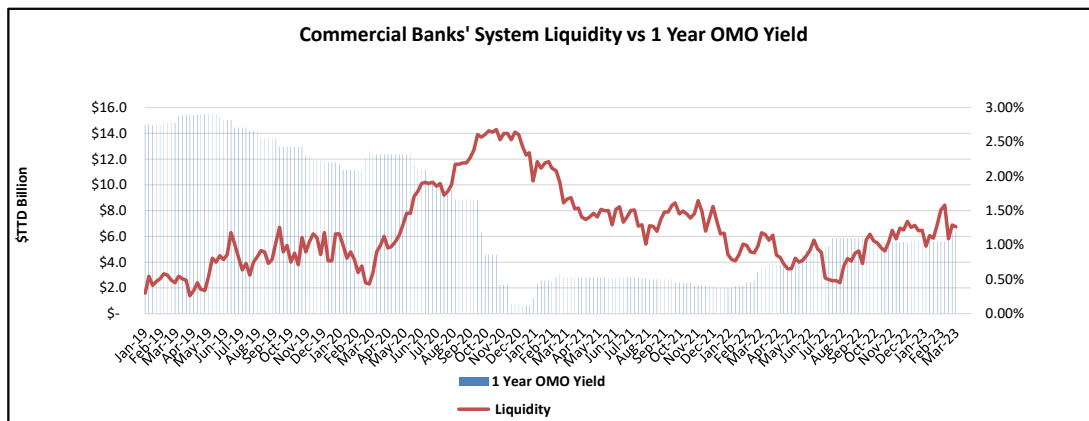
