#### **EQUITY SUMMARY**

This week saw 887,370 shares traded on the First Tier Market, a decrease of 49.04 per cent on last week's total of 1,741,338 shares crossing the floor. The value of the shares traded was down 31.43 per cent to \$5,898,547.72 from the previous week's value of \$8,602,769.10. Massy Holdings Limited (MASSY) was the volume leader this week with 54.07 per cent of the market activity or 479,763 shares traded, followed by National Enterprises Limited (NEL) with 9.94 per cent of the market activity or 88,164 shares traded. In third place was National Flour Mills Limited (NFM) with 8.90 per cent or 78,943 shares traded. These shares accounted for 72.90 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 0.40 per cent or 4.15 points to close at 1,044.72. The All Trinidad and Tobago Index ended at 1,529.10, down 0.61 per cent or 9.42 points. The Cross Listed Index closed at 73.67, an increase of 0.29 per cent or 0.21 points. The Small and Medium Enterprise Index closed at 91.85, up 5.99 per cent or 5.19 points. This week there were 8 shares advancing and 10 shares declining, while 2 shares were at their 52-week high, and 4 shares were at their 52-week low.



The major advance this week was L.J. Williams Limited "B" (LJWB) up 11.11 per cent or \$0.10 to close at \$1.00. In second place was The West Indian Tobacco Company Limited (WCO) with an increase of 7.77 per cent or \$0.39 to close at \$5.41. In third place was GraceKennedy Limited (GKC) up 7.50 per cent or \$0.27 to close at \$3.87.

Trinidad Cement Limited (TCL) was the major decline this week down 6.05 per cent or \$0.13 to close at \$2.02, its 52 week low. Guardian Holdings Limited (GKC) followed with a decrease of 4.36 per cent or \$0.73 to close at \$16.02. In third place was NCB Financial Group Limited (NCBFG) down 4.35 per cent or \$0.10 to close at \$2.20.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 787 Calypso Macro Index Fund (CALYP) units traded this week with a value of \$19,635.65. CALYP's unit price closed at \$24.95 up 6.35 per cent or \$1.49.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) and no Eric Solis Marketing Limited (SOLIS) shares traded this week. 505 Endeavour Holdings Limited (EHL) shares traded this week with a value of \$9,090.00. SOLIS's share price closed at \$4.00 and CINE1's share price closed at \$5.50, both unchanged from last week. EHL share price closed at \$18.00 up 6.82 per cent or \$1.15.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


