EQUITY SUMMARY

This week saw 2,342,197 shares traded on the First Tier Market, an increase of 1.23 per cent on last week's total of 2,313,774 shares crossing the floor. The value of the shares traded increased by 6.57 per cent to \$28,666,071.60 from the previous week's value of \$26,899,645.99. Massy Holdings Limited (MASSY) was the volume leader this week with 56.51 per cent of the market activity or 1,323,673 shares traded. In second place was National Enterprises Limited (NEL) with 10.41 per cent or 242,757 shares traded, followed by GraceKennedy Limited (GKC) with 5.86 per cent or 137,152 shares traded. These shares accounted for 72.78 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 0.31 per cent or 3.89 points to close at 1,267.48. The All Trinidad and Tobago Index ended at 1,927.58 down 0.02 per cent or 0.45 points. The Cross Listed Index fell by 1.33 per cent or 1.06 points to close at 78.52. The Small and Medium Enterprise Index ended at 69.27, up 11.49 per cent or 7.14 points from last week. This week there were 7 shares advancing and 12 shares declining, while 2 shares were at their 52-week high and 5 shares were at their 52-week low.



The major advance this week was MASSY up 3.00 per cent or \$0.15 to close at \$5.15, followed by Trinidad and Tobago NGL Limited (NGL) with an increase of 2.70 per cent or \$0.50 to close at \$19.00. First Citizens Group Financial Holdings Limited (FCGFH) was in third place with an increase of 2.12 per cent or \$1.03 to close at \$49.53.

Guardian Media Limited (GML) was the major decline this week down 8.37 per cent or \$0.21 to close at \$2.30. In second place was Point Lisas Industrial Port Development Corporation Limited (PLD) with a decrease of 6.57 per cent or \$0.23 to close at \$3.27, followed by The West Indian Tobacco Company Limited (WCO) down 5.68 per cent or \$0.82 to close at \$13.61, its 52 week low.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market 634 Calypso Macro Index Fund (CALYP) units traded this week, with a value of \$13,841.20. CALYP's unit price closed at \$21.85, down 1.53 per cent or \$0.33 from last week.

On the Small and Medium Enterprise Market, 973 Endeavour Holdings Limited (EHL) shares traded this week, with a value of \$11,848.45. EHL's share price closed at \$12.65, up 13.45 per cent or \$1.50 from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


