EQUITY SUMMARY

This week saw 3,663,879 shares traded on the First Tier Market, an increase of 216.16 per cent on last week's total of 1,158,857 shares crossing the floor. The value of the shares traded was up 75.94 per cent to \$14,607,234.41 from the previous week's value of \$8,302,298.21. MASSY Holdings Limited (MASSY) was the volume leader this week with 51.15 per cent of the market activity or 1,874,028 shares traded, followed by NCB Financial Group Limited (NCBFG) with 18.74 per cent of the market activity or 686,436 shares traded. In third place was JMMB Group Limited (JMMBGL) with 17.86 per cent or 654,548 shares traded. These shares accounted for 87.75 per cent of the shares traded this week.

The Indices ended the week in positive territory. The Composite Index increased by 0.28 per cent or 2.85 points to close at 1,038.84. The All Trinidad and Tobago Index ended at 1,562.68, up by 0.34 per cent or 5.24 points. The Cross Listed Index rose by 0.06 per cent or 0.04 points to close at 66.95. The Small and Medium Enterprise Index closed at 88.01, unchanged from last week. This week there were 9 shares advancing and 5 shares declining, while 1 share was at its 52-week high, and 6 shares were at their 52-week low.



The major advance this week was Prestige Holdings Limited (PHL) up 6.97 per cent or \$0.70 to close at \$10.75. In second place was Unilever Caribbean Limited (UCL) with an increase of 4.36 per cent or \$0.48 to close at \$11.48. In third place was One Caribbean Media Limited (OCM) up 3.09 per cent or \$0.09 to close at \$3.00.

L.J Williams Limited “B” (LJWB) was the major decline this week down 26.77 per cent or \$0.34 to close at \$0.93, its 52-week low. Trinidad Cement Limited (TCL) followed with a decrease of 6.45 per cent or \$0.18 to close at \$2.61. In third place was Trinidad and Tobago NGL Limited (NGL) down 4.26 per cent or \$0.20 to close at \$4.50, its 52-week low.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 4,137 Calypso Macro Index Fund (CALYP) units traded this week, at a value of \$96,758.05. CALYP’s unit price closed at \$23.66, up 0.25 per cent or \$0.06 from last week.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1), Endeavour Holdings Limited (EHL) or Eric Solis Marketing Limited (SOLIS) shares traded this week. SOLIS’ share price closed at \$4.20, EHL’s share price closed at \$17.00, and CINE1’s share price closed at \$5.90, all unchanged from the previous week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.

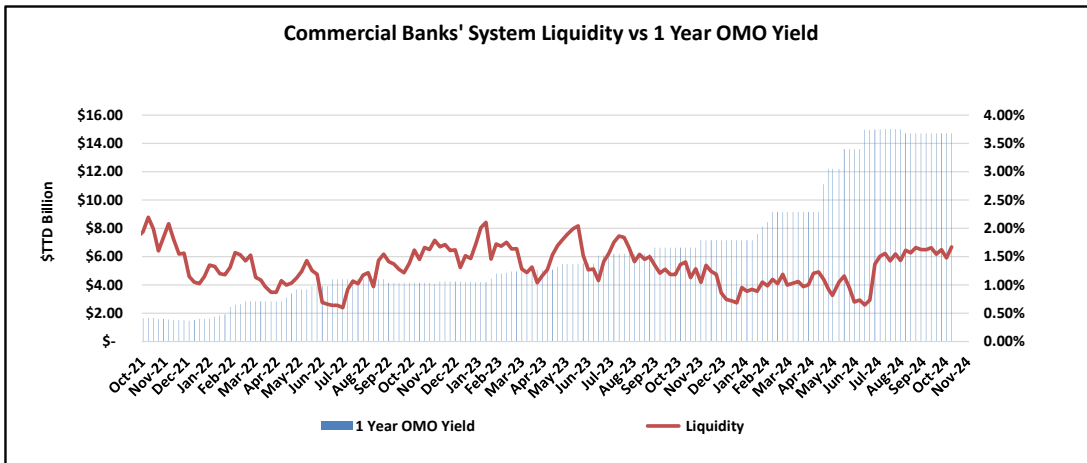
