EQUITY SUMMARY

This week saw 2,306,739 shares traded on the First Tier Market, an increase of 34.03 per cent on last week's total of 1,721,054 shares crossing the floor. The value of the shares traded was down 8.28 per cent to \$16,020,105.82 from the previous week's value of \$17,467,254.26. NCB Financial Group Limited (NCBFG) was the volume leader this week with 29.05 per cent of the market activity or 670,100 shares traded, followed by MASSY Holdings Limited (MASSY) with 27.18 per cent of the market activity or 627,072 shares traded. In third place was GraceKennedy Limited (GKC) with 10.64 per cent or 245,492 shares traded. These shares accounted for 66.88 per cent of the shares traded this week.



The Indices ended the week in negative territory. The Composite Index decreased by 1.12 per cent or 11.97 points to close at 1,054.06. The All Trinidad and Tobago Index ended at 1,569.87, down by 0.92 per cent or 14.61 points. The Cross Listed Index fell by 1.79 per cent or 1.28 points to close at 70.28. The Small and Medium Enterprise Index closed at 88.01, unchanged from last week. This week there were 9 shares advancing and 10 shares declining, while 1 share was at its 52-week high, and 6 shares were at their 52-week low.

The major advance this week was One Caribbean Media Limited (OCM) up 6.79 per cent or \$0.19 to close at \$2.99. In second place was NCBFG with an increase of 4.65 per cent or \$0.10 to close at \$2.25. In third place was JMMB Group Limited (JMMBGL) up 3.92 per cent or \$0.04 to close at \$1.06.

Trinidad Cement Limited (TCL) was the major decline this week down 8.43 per cent or \$0.22 to close at \$2.39, its 52 week low. The West Indian Tobacco Company Limited (WCO) followed with a decrease of 7.19 per cent or \$0.43 to close at \$5.55. In third place was CIBC Caribbean Bank Limited (CIBC) down 5.75 per cent or \$0.46 to close at \$7.54.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 1,769 Calypso Macro Index Fund (CALYP) units traded this week, at a value of \$41,749.53. CALYP's unit price closed at \$23.60, down 0.30 per cent or \$0.07 from last week.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1), while 60 Endeavour Holdings Limited (EHL) shares traded this week at value of \$1,080.00. 5 Eric Solis Marketing Limited (SOLIS) shares traded this week at a value of \$21.25. SOLIS share price closed at \$4.20, EHL's share price closed at \$17.00, and CINE1's share price closed at \$5.90, all unchanged from the previous week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.

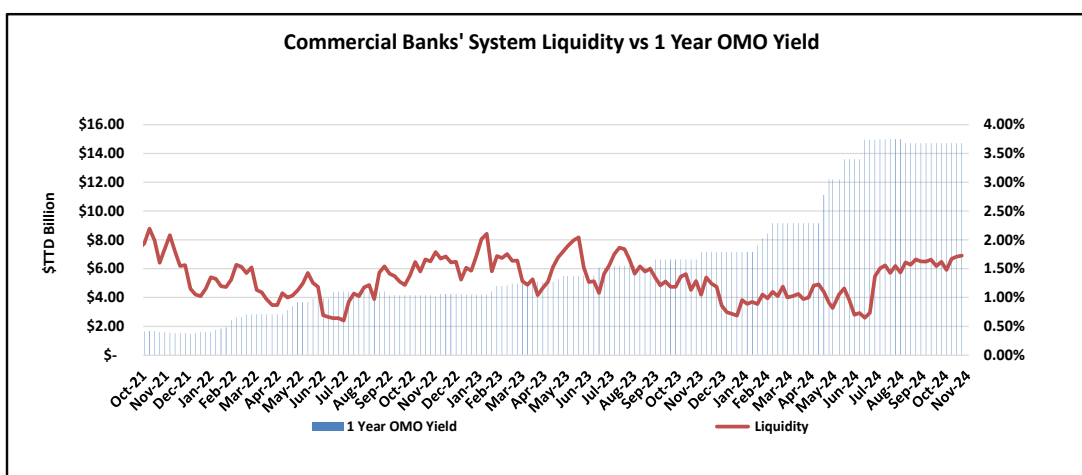
