### **EQUITY SUMMARY**

This week saw 1,037,830 shares traded on the First Tier Market, a decrease of 52.13 per cent on last week's total of 2,168,091 shares crossing the floor. The value of the shares traded was down by 39.16 per cent to \$11,945,210.32 from the previous week's value of \$19,633,732.62. Massy Holdings Limited (MASSY) was the volume leader this week with 31.67 per cent of the market activity or 328,718 shares traded. In second place was NCB Financial Group Limited (NCBFG) with 20.54 per cent or 213,171 shares traded, followed by GraceKennedy Limited (GKC) with 18.01 per cent or 186,939 shares traded. These shares accounted for 70.23 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 0.91 per cent or 10.92 points to close at 1,190.94. The All Trinidad and Tobago Index ended at 1,813.08 down 1.18 per cent or 21.71 points. The Cross Listed Index advanced by 0.12 per cent or 0.09 points to close at 73.52. The Small and Medium Enterprise Index ended at 79.99, unchanged from last week. This week there were 9 shares advancing and 12 shares declining, while 1 share was at its 52-week low.



The major advance this week was Trinidad and Tobago NGL Limited (NGL) up 18.02 per cent or \$1.98 to close at \$12.97, Guardian Media Limited (GML) followed with an increase of 9.45 per cent or \$0.19 to close at \$2.20. In third place was The West Indian Tobacco Company Limited (WCO) with an increase of 2.90 per cent or \$0.29 to close at \$10.29.

Angostura Holdings Limited (AHL) was the major decline this week down 8.89 per cent or \$2.00 to close at \$20.50. In second place was One Caribbean Media Limited (OCM) with a decrease of 8.40 per cent or \$0.33 to close at \$3.60, followed by National Flour Mills Limited (NFM) down 6.13 per cent or \$0.10 to close at \$1.53.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market 20,010 Calypso Macro Index Fund (CALYP) units traded this week, with a value of \$450,626.10. CALYP's unit price closed at \$22.61, down 0.49 per cent or \$0.11 from last week.

On the Small and Medium Enterprise Market, 170 Endeavour Holdings Limited (EHL) shares traded at a value of \$2,550.00 while no CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$15.00, unchanged from last week, while CINE1 closed at \$7.40, unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


