EQUITY SUMMARY

This week saw 1,833,224 shares traded on the First Tier Market, a decrease of 58.54 per cent on last week's total of 4,421,654 shares crossing the floor. The value of the shares traded was down 42.39 per cent to \$16,387,542.06 from the previous week's value of \$28,444,113.76. Massy Holdings Limited (MASSY) was the volume leader this week with 48.24 per cent of the market activity or 884,292 shares traded, followed by JMMB Group Limited (JMMBGL) with 32.66 per cent of the market activity or 598,780 shares traded. In third place was NCB Financial Group Limited (NCBFG) with 7.38 per cent or 135,351 shares traded. These shares accounted for 88.28 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 0.06 per cent or 0.59 points to close at 1,038.63. The All Trinidad and Tobago Index ended at 1,553.98, up by 0.10 per cent or 1.49 points. The Cross Listed Index decreased by 0.57 per cent or 0.39 points to close at 68.18. The Small and Medium Enterprise Index closed at 88.01, unchanged from last week. This week there were 7 shares advancing and 8 shares declining, while 2 shares was at its 52 week high, and 6 shares were at their 52 week low.



The major advance this week was Unilever Caribbean Limited (UCL) up 2.76 per cent or \$0.29 to close at \$10.79. In second place was Point Lisas Industrial Port Development Company Limited (PLD) with an increase of 2.56 per cent or \$0.08 to close at \$3.20. In third place was National Enterprises Limited (NEL) up 2.08 per cent or \$0.06 to close at \$2.94.

National Flour Mills Limited (NFM) was the major decline this week down 3.41 per cent or \$0.06 to close at \$1.70. Angostura Holdings Limited (AHL) followed with a decrease of 3.03 per cent or \$0.50 to close at \$16.00, its 52 week low. In third place was NCBFG down 1.71 per cent or \$0.04 to close at \$2.30, its 52 week low.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 10 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$240.00. CALYP's unit price closed at \$24.00, unchanged from last week.

On the Small and Medium Enterprise Market, 20 CinemaOne Limited (CINE1) shares traded, valued at \$110.00. No Endeavour Holdings Limited (EHL) shares traded, and no Eric Solis Marketing Limited (SOLIS) shares traded this week. SOLIS' share price closed at \$4.20, EHL's share price closed at \$17.00, and CINE1's share price closed at \$5.90, all unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.

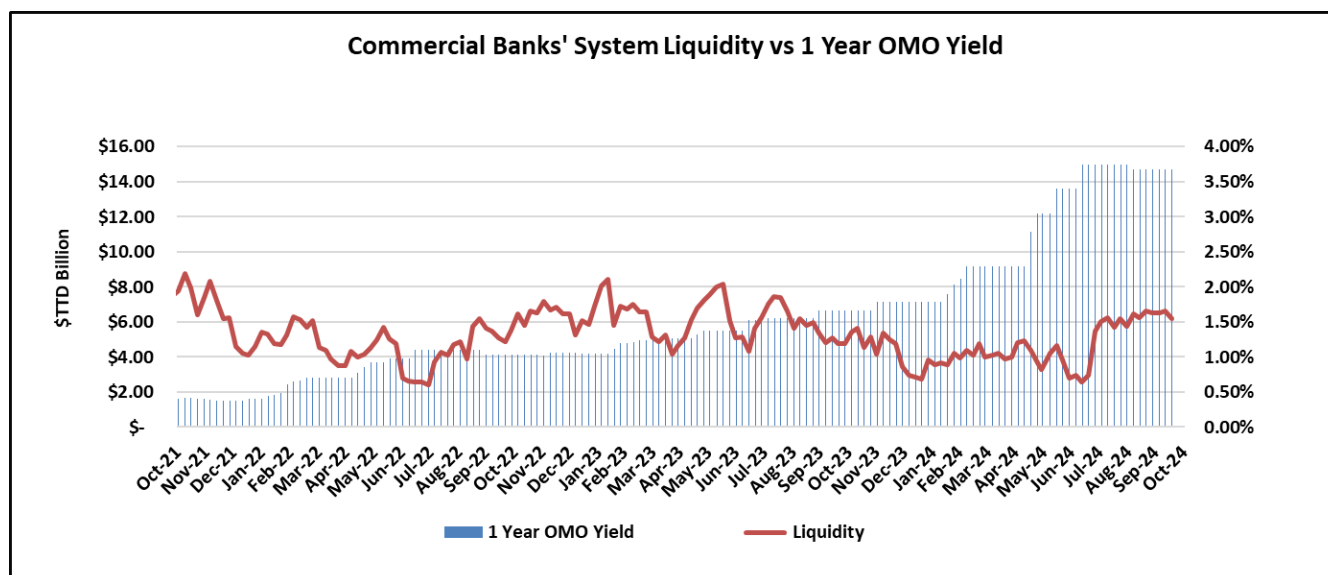
