EQUITY SUMMARY

This week saw 4,170,328 shares traded on the First Tier Market, an increase of 48.68 per cent on last week's total of 2,804,914 shares crossing the floor. The value of the shares traded was down 16.25 per cent to \$11,128,740.76 from the previous week's value of \$13,287,869.37. One Caribbean Media Limited (OCM) was the volume leader with 64.35 per cent of the market activity or 2,683,694 shares traded. In second place was Massy Holdings Ltd. (MASSY) with 10.18 per cent of the market activity or 424,388 shares traded, followed by National Enterprises Limited (NEL) with 7.09 per cent or 295,788 shares traded. These shares accounted for 81.62 per cent of the shares traded this week.

The Indices ended the week in positive territory. The Composite Index increased by 1.56 per cent or 14.79 points to close at 961.39. The All Trinidad and Tobago Index ended at 1,394.60, up 0.73 per cent or 10.11 points. The Cross Listed Index closed at 69.63, an increase of 4.19 per cent or 2.80 points. The Small and Medium Enterprise Index closed at 92.68, unchanged from last week. This week there were 8 shares advancing and 12 shares declining, while no share was at its 52-week high, and 2 shares were at their 52-week low.



The major advance this week was CIBC Caribbean Bank Limited (CIBC) up 6.83 per cent or \$0.53 to close at \$8.29. In second place was Trinidad and Tobago NGL Limited (NGL) up 4.47 per cent or \$0.25 to close at \$5.84, MASSY followed with an increase of 3.61 per cent or \$0.12 to close at \$3.44.

National Flour Mills Limited (NFM) was the major decline this week, down 4.03 per cent or \$0.06 to close at \$1.43, Point Lisas Industrial Port Development Corporation Limited (PLD) followed with a decrease of 1.77 per cent or \$0.09 to close at \$5.00. In third place was OCM down 1.46 per cent or \$0.02 to close at \$1.35.

There was no activity on the Second Tier Market.

There was no activity on the TTD Mutual Fund Market.

On the Small and Medium Enterprise Market, no CinemaOne Limited (CINE1) shares traded this week. 1 Eric Solis Marketing Limited (SOLIS) share traded with a value of \$3.91, 75 Medcorp Limited (MED) shares traded with a value of \$3,525.00 and 6 Endeavour Holdings Limited (EHL) shares traded with a value of \$110.10. CINE1's share price closed at \$4.68, SOLIS's share price closed at \$3.91, EHL share price closed at \$18.44 and MED's share price closed at \$46.01, all unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) or A.S Bryden & Sons Holdings 6.00% Class A Preference shares (ASBH6.00) shares traded this week. MPCCEL shares closed at US\$0.98, while ASBH6.00 shares closed at US\$1.00, both unchanged from last week.

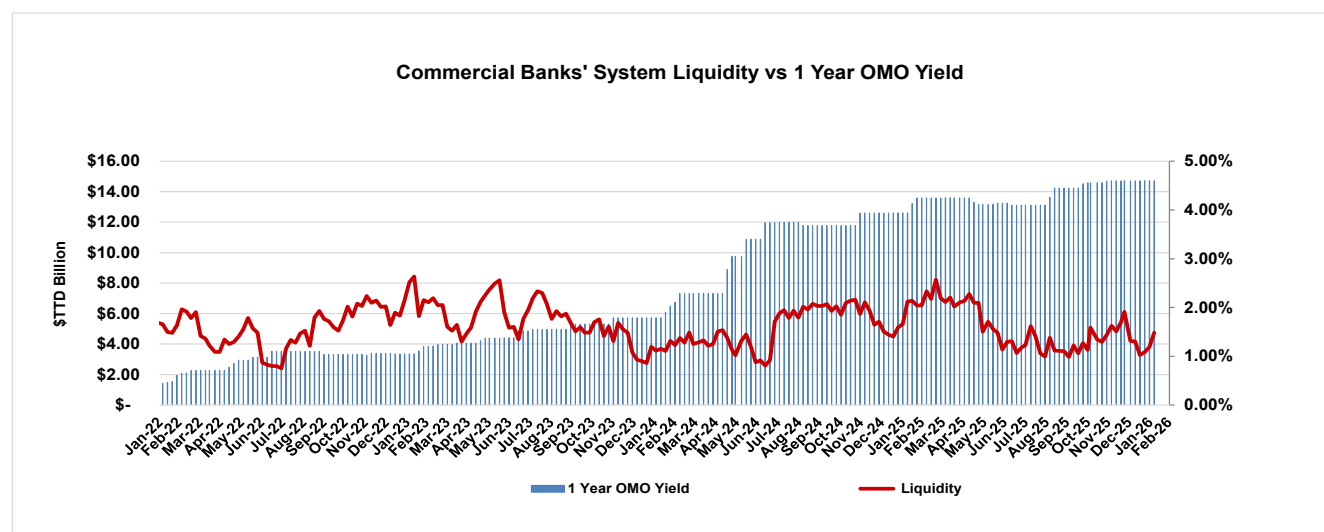
